BA-7 #4 reflecting increased spending authority for self-generated revenues realized by the SU Law Center in the amount of \$2,014,000 as a result of increased tuition and enrollment in FY 2010-11; and, a decrease in spending authority in the amount of \$2,014,000 from the SU Baton Rouge Campus as a result of enrollment numbers being less than projected during FY 2010-11.

### AGENDA ITEM 6: INFORMATIONAL ITEM

### A. Discussion of SUBR Budget

Chancellor James Llorens provided a status report on the Southern University — Baton Rouge's 2011-2012 Operating Budget. He reminded the Committee of the reductions of over 17 million dollars in State Appropriations that SUBR has sustained over the past 30 months. This fiscal year, the Administration will have to implement a number of actions to offset an anticipated shortfall in the amount of \$10 million. Daily meetings are being held by a University Budget Committee composed of Campus Administrators, Faculty, Staff and Student Representatives to address the budget shortfall and to attempt to avoid having to declare financial exigency.

Some of the strategies developed to date to address the financial problem include reducing costs in the following areas:

- o Adjunct Faculty and Faculty Overloads
- o Vacant Positions
- o Personnel
- o Utilities
- o Summer Session

These and other reductions will require the University to undergo a restructuring and redesign to ensure the continued efficiency and effectiveness of its operations.

The implementation of additional on-line course offerings and certificate programs are also being considered to generate needed revenues.

Several suggestions were offered by members of the Committee to the Administration -

- O Develop and submit to the Board a three- to five year plan for Southern University at Baton Rouge
- O Determine which program accreditations may be impacted negatively by the budget crisis.
- o Determine the impact of budget actions on Student Credit Hours
- Make reductions to the administrative staff at the System and Baton Rouge Campus levels
- O Develop strategies for reducing utility costs and to attract grants that are available to assist the University in becoming a green campus.
- Provide weekly or bimonthly updates to Board Members on the status of the SUBR budget
- O Develop a game plan to enhance SUBR's success in the areas of student recruitment, retention and rewarding (graduation)

FY 2011-2012 Budget recommendations for Southern University at Baton Rouge are scheduled for submission for Board approval in August.

### A. Advantage of SUBR's Membership in SWAC

In the report by Chancellor Llorens, the following were listed as advantages to SUBR due to its membership in the Southwestern Athletic Conference.

- Receives a share of proceeds from SWAC Conference games. Last year, the University's share amounted to \$30,000.
- Received approximately \$80,000 annually from NCAA via SWAC for needy students
- Certain games are televised on ESPN
- Discounts in athletic shoes purchased from NIKE and Russell Athletics
- Automatic participation in conference tournaments

Note: SUBR has been sanctioned by the NCAA and SWAC because of the low academic performance rates of its student-athletes. The University is banned from televised conference bans and post season conference play.

Southern University – Baton Rouge has held membership in SWAC since 1936. Annual SWAC membership dues are \$35,000 which represents a recent increase of ten percent. The Chancellor of Southern University – Baton Rouge sits on the SWAC Council of Presidents and Chancellors, the organization's governing body.

Several Committee Members agreed on the need for more assistance from SWAC to its member schools. Further, in light of recent ban by the NCAA and SWAC, SUBR must attract new revenues to support its athletics program, i.e., auctioning of naming rights in A.W. Mumford Stadium to corporate sponsors.

The Chancellor announced that the search for the Director of Athletics for SUBR is ongoing and application review will begin soon. The ideal candidate is one who can successfully market SUBR's Athletic Programs and put in place a mechanism that will enhance student-athletes' success academically and athletically.

# Chancellor's Report





### SIGNIFICANT ACCOMPLISHMENTS/ACHIEVEMENTS

### **ExxonMobil Representatives Meet with SUBR Officials**

On Wednesday, July 20, 2011, the Chancellor, Special Assistant Margaret Ambrose, Interim Athletic Director Sandy Pugh and Ms. Monique Edwards met with four representatives from ExxonMobil. Two of these representatives were Southern University graduates.

The purpose of the meeting was to introduce the Chancellor to the ExxonMobil Team and to brief the Chancellor on what and how ExxonMobil continues to contribute to SUBR through student scholarships, student internships, and permanent employment of some SUBR graduates. Other ExxonMobil sponsored activities include the Bernard Harris Summer Science Camp, Engineering Summer Institute, Science Quest Program and the Wildlife Habitat Project.

Representatives from ExxonMobil also participate in the Southern University Business and Industry Cluster, and they participate as members of the Engineering Council of Visitors. The University also receives departmental and college grants, especially for the Colleges of Business and Engineering. ExxonMobil sponsors one of the labs in the College of Engineering (\$25K commitment).

Also of great significance is the SU Alumni ExxonMobil SU Employee 3 to 1 Educational Matching Gift program. In 2010, the Matching Gift Program yielded \$65,586. The total amount for 2011 has not been reported yet.

The University's intent is to continue to build upon its existing mutually beneficial relationship with ExxonMobil.

### <u>SUBR Athletic Faculty Representative Appointed to NCAA Management Cabinet</u>



Dr. Doze Butler currently serves as SUBR's Faculty Representative for the Department of Athletics. Since her appointment, Dr. Butler has become a full participant in a number of NCAA related activities. She was recently to the NCAA's appointed Champions/Sports Management Cabinet. a group that oversees drug testing and education, rules and Olympic sports issues. The Cabinet meets up to three times a year and has oversight authority of all NCAA Division 1 National Championships and National Collegiate Championships. The Cabinet also makes recommendations regarding sports science issues, including injury surveillance, drug education, drug testing, and playing and practice seasons.

### School of Nursing Hosts National HBCU Schools of Nursing Day

On July 28, 2011, the SUBR School Nursing served as host for a verv special day - the Historically Black Colleges and Universities Schools Nursina Day. From 8:00a.m. to 5:00p.m. nursing professionals from across the USA convened on the Baton Rouge campus.



Several informative sessions were held. Those in attendance were encouraged to continue providing innovative leadership, mentoring and instruction for those students who wish to pursue a career in nursing. The one-day activity was co-hosted by SUBR and the Health Resources and Services Administration of the U. S. Department of Health. Most of the participants were deans or senior nursing administrators. The event gave those in attendance the opportunity to exchange ideas and share experiences related to recruitment, retention and the training of nursing students. Emphasis was placed on the fact that these students must be prepared to serve a diverse population, and, most especially, the underserved.

### <u>SUBR Honors College Student Selected as ETS Presidential Scholarship Recipient</u>

Russell Ledet, a senior in the Dolores Margaret Richard Spikes Honors College, was recently selected as a 2011-2012 Educational Testing Service (ETS) Presidential Scholarship recipient for HBCU students. Russell is one of eight students who were chosen from among a number of very academically talented students who submitted applications.

The University nominated three students and Russell was one of the eight students selected from a large pool



of students from across the country who applied. We are extremely proud of his accomplishment and extend to him high commendations.

### Southern Laboratory School Instructor Receives Educator Award



Ann Brown, a Southern University Laboratory School English teacher, was recently awarded the Distinguished Clinician Award by the Louisiana Association of Teacher Educators (LAATE).

The award is given each year by the LAATE in recognition of practicing clinicians for their professional knowledge, skills and outstanding work to ensure successful student teaching experiences. Ms. Brown and four other outstanding teachers were presented with this award during a luncheon at Northwestern State University.

This outstanding Lab School instructor has been employed at the SU Laboratory School for 11 years. She also has 18 years of experience at the Baton Rouge High School. Commendations are extended to this instructor for her exemplary work.

### "Human Jukebox" Named best HBCU Marching Band

The Southern University Marching Band has been selected as the top marching band among the nation's historically black colleges, according to a national news magazine website.

HBCU Digest listed SU's "Human Jukebox" as the number one HBCU marching band, outranking rivals Florida A&M University's "Marching 100," Jackson State University's "Sonic Boom of the South," Grambling State University's Tiger Marching Band and the Bethune-Cookman University "Marching Wildcats."

"To even be mentioned in the same breath as these great marching bands is something to treasure," said Director of Bands Lawrence Jackson. "To be considered the best is an awesome payoff for the hours of sacrifice invested by our young men and women."

Jackson, a former Jukebox member himself, said the marching has had to be innovative in the past several years to "maintain the legacy of the great band directors and members before me."

"I am honored that someone would consider our band as the best HBCU band in the country," Jackson said. "This is a tribute to the hard work of my staff and the student musicians that we are extremely blessed to have at Southern University."

### SU to offer vaccinations to SU students

The Southern University Student Health Center has partnered with the Louisiana Department of Health and Hospitals to provide free vaccinations to SU students who are 18 years old and younger.

The partnership is an effort to assist incoming freshmen who have not received all of their vaccinations and cannot provide proof of their immunization compliance. Also, to qualify, the student can have only University provided health insurance coverage.

The Health Center has the vaccines for whooping cough, measles, mumps and rubella, human papillomavirus, tetanus, meningitis, and hepatitis B.

Louisiana law (R.S. 17:170 - Schools of Higher Learning) requires proof of dates of immunization against measles, mumps, rubella, and tetanus-diphtheria for all first-time college students.

### <u>Institute for Research, Training and Public Service Initiates African</u> <u>American Mayors Project</u>

The Institute for Research Training and Public Service, housed in the Nelson Mandela School for Public Policy and Urban Affairs, has begun research for an initiative called "The African American Mayor's Project." Dr. Huey Perry, Executive Director of the Institute, is providing the leadership for this project.

The ongoing research is the basis for three proposals that are being developed for possible external funding. The director believes that this project fills an important niche in research on African American mayors. This project grew out of work that was done over the last year on three individual studies related to African American mayors. "The goal is for the Institute for Research, Training and Public Service to become the principal repository of research and data on African American mayors in the United States," said Institute Director, Dr. Huey Perry.

### **SU Scientist Earns \$200,000 DOE Grant**



The Department of Energy has selected Southern University as one of the four institutions annual chosen in an competition for fossil energy research ideas from the Historically Black nation's Colleges and Universities and Other Minority Institutions.

The Department of Energy will provide \$200,000 to Southern and Dr. Shizhong Yang, a

computational scientist in Southern's Department of Computer Science.

With temperatures reaching 100 degrees, approximately 150 farmers, agricultural producers, agricultural professionals and other interested people attended the 10th Morehouse Parish Black Farmers and Landowners Association Annual Field Day. The field day and farm tour was held on Friday, July 22nd, and began on the farm of Harper Armstrong in Collinston, Louisiana.

This annual event was started by a group of farmers in Morehouse Parish who early on recognized the need for sharing information and experiences to help themselves and to increase awareness for the next generation. They later organized themselves into the Morehouse Parish Black Farmers and Landowners Association, and have worked diligently ever since to enhance the education and opportunities for farmers in north Louisiana.

Odis Hill, Assistant Area Agent with the Southern University Ag Center, is a founding member of the Association and one of the key organizers of the annual field day. During the program, Hill also shared with the group the history of the event. He noted that during the first year, farmers were the only Representamembers. tives from Southern University got involved during the second year and LSU came aboard during vear three.

There were five stops on the tour. It began with the Armstrong soybean plot, followed by the cotton plot. This was followed by a demonstration on harvesting corn at the Hill farm and next came a visit to Antwain Downs' corn plot. The final stop of the farm tour was at a cattle operation on the farm of Curtis Payton. This year as in the previous years, the day ended with lunch at the Cooperative Extension Office in Bastrop.

This annual field day and farm tour is an excellent example of true partnerships and collaborative efforts. So many partners come together annually to ensure the continued success of this event. Mr. Armstrong, president of the group expressed his appreciation to Southern University Ag Center. LSU AgCenter, USDA/ NRCS. Monsanto, FMC. Dupont. the Growers Council and all who support the Association's efforts.

Special guests for this year's field day were Dr. Dewayne Goldman, with Monsanto, Ms. Kim Davis, from the National Growers Council who attended along with farmers from North Carolina, Alabama, Mississippi, Florida and Virginia.

### Food and Agricultural Sciences Leadership Academy

On July 1st in Room 191 of the SU Ag Center, the commencement ceremony for the Food and Agricultural Sciences Leadership Academy was held. This celebration highlighted the work and achievements of 17 rising high school seniors in schools around the state of Louisiana. The ceremony began with a welcome by Dr. Leodrey Williams, Chancellor. Ms. Lucille Dunn of the Society of St. Vincent de Paul was the keynote speaker at the commencement ceremony.

The Leadership Academy is a twoyear summer program implemented in two phases. The overall goal of Phase I is to assist program participants increase their ACT score in order to qualify for the Tuition Opportunity Program for Students (TOPS) award. This phase began on May 29th, and for five (5) weeks the students were engaged in a rigorous course of study including ACT preparation/ academic enhancement activities, service learning and leadership development. They endured 18 hours of ACT preparation with Princeton Review, three (3) practice 3.5 hour long ACT test, 20 hours of instruction in each of the following subjects: English, Social Studies, Math and Science to include a three-hour lab in each subject, and exposure to the careers and majors in the Food and Agricultural Sciences. Phase II will be during the summer of 2012.

Although the majority of the time was spent focusing on academic enhancement and career development activities, two other components of the Leadership Academy were included, leadership development and service learning.

The primary concept of leadership development highlighted during this experience focused "Developing the Leader Within." Through a brain storming session, the class developed their own definition of leadership which is: the position or function of an individual whereby he/she is able to provide guidance and direction to a group of people and move them in a positive direction. In addition to defining the term, the class became more familiar with the characteristics/positive attributes of a leader and through self-discovery and assessment, were able to identify their individual leadership skills and styles. Most imporpersonal SWOT tantly. (Strengths, Weaknesses, Opportunities and Threats) Analysis was conducted where each student gave a painstakingly honest assessment of his/her individual strengths and weaknesses. Each student received a copy of the 7 Habits of Highly Effective Teens, and the companion workbook both by Steven Covey, and also Who Moved My Cheese for Teens by Spencer Johnson, M.D.

While maintaining a very rigorous schedule, the students managed to perform 20 hours of community service volunteering with the following organizations: Ms. Jenga Nwendo, Laurentine Ernst Community Garden, New Orleans, where they assisted in the maintenance of a community garden in the lower ninth ward and the East Baton Rouge Parish Animal Control, Baton Rouge, where they provided exercise and nurturing to abandoned animals being placed for adoption. The students also volunteered with The National Organization of Black Natural Resources Conservation Services, Employees - Louisiana Chapter, Galliano, where they planted grass along a two-mile stretch of beach on Grand Isle, to fight coastal erosion and to aid in coastal restoration; and the Skills Enhancement Academy, the Wesley Foundation, Baton Rouge, where they mentored 2nd - 5th graders, to include discussing manners, proper behavior, the importance of school and future careers. Their final service learning project was with the Mili-Community. Family tarv Youth Extension Project, Southern University Ag Center, where they assisted in the maintenance of the university-based garden.



### SU Ag Center Agents Participate in Annual Development Training

Southern University Ag Center held its 2<sup>nd</sup> Annual Community and Economic Development training for 17 participants on June 27. This year's training focused on the project, Building Opportunities through Leadership Development (BOLD). BOLD, a statewide leadership development program focuses on building leaders from rural and underserved populations in hopes of assisting residents with addressing issues and concerns of their communities. It is built on the precept that indige-

Nelson-Smith has been selected to participate in the 2011 Adult Higher Education Alliance Annual Conference in Indianapolis this fall to present the BOLD project.

Dr. Kenyetta Nelson-Smith is SU Ag Center's assistant specialist of community and economic development and director of the BOLD project.

### SU Ag Center Staff Attend 1890 Exchange Conference

Director Gloria London, Business Development Specialist Eual Hall, Technology Specialists Wilbert Harris and William Augustine from the Center for Rural and Small Business Development at the SU Ag Center converged with 17 other 1890 Land Grant Universities and Tuskegee Institute in Charleston, SC for the 1890 Exchange Conference, July 12-15.

The purpose of this Conference was to have a conversation between USDA Rural Development and 1890 Institution Partners of Rural Development programs and resources, how they impact economically challenged rural communities; and how Rural Development can utilize 1890 partners as outreach resources.

USDA administrator Judith Canaes, Keynote Luncheon Speaker, informed the group that change is in the making and having the appropriate means of communication is most critical due to budget cuts. She emphasized the need to "Tell our success stories and present our activities to whom it impacts the most."

The next move will involve: Identifying the feasibility for developing more significant projects in 1890 targeted rural communities and engaging 1890 and Rural Development programs and resources for implementation: Working gether to Impact Economically Challenged Rural Communities; and development projects that will alleviate erosion of the economic empowerments. These projects will include Business incubators; Mom & Pop Grocery stores; Community youth and senior centers; Community library/technology centers; Cooperatives consisting of fruit/

vegetable processing facilities; and the ability to establish an Intermediate Relending Loan Program.

### Southern University Urban Forestry, Penn State Plant Pathology Collaborate

On July 10-12, Dr. Dan Collins, professor, urban forestry, SU Ag Center, and four students, including one undergraduate, from the Department of Urban Forestry at Southern University, Baton Rouge, visited Penn State University to participate in a Short Course on Agricultural Plant Biosecurity developed by the Department of Plant Pathology.

Day 1 of the rigorous 2-day course included a half-day of lectures on invasive species and biocontrol strategies by Dr. Don Davis, the role of APHIS in pathogen forensics by Grace O'Keefe, and Agricultural Biosecurity Initiatives by Dr. Gretchen Kuldau. In addition, each graduate student from Southern University made a brief presentation summarizing his/her research.

On day 2, the group travelled first to the Pennsylvania Department of Agriculture in Harrisburg, PA, to tour research and diagnostic facilities for plant pathogen detection with Dr. Ruth Welliver and Dr. Seong Kim and the insect ID lab with Dr. Sven Spichiger. Topics discussed included the eradication efforts for plum pox virus, surveys for Phytophthora and Ralstonia, and introductions of the longhorn beetle and the green ash borer. The group then travelled to the Penn State Fruit Research and Extension Center for an afternoon tour of tree fruit research programs by Drs. Henry Ngugi and John Halbrendt where they discussed studies of resurging plant diseases and their detection. The Biosecurity Class then travelled to Frederick, MD, to visit Dr. Doug Luster and colleagues at the USDA-ARS Biocontainment Greenhouse and tour the APHIS

Training Facilities, before returning home to Southern University.

Penn State Plant Pathology and Southern University Urban Forestry are collaborators in Agricultural Biosecurity Education. The USDA/NIFA funded the course in part through a Capacity Building Grant to Enhance Graduate Education and Training in Global Food Security and Agricultural Biosecurity. 

### Southern University Ag Center Professor Emeritus Co-authors Paper

Dr. James McNitt, Professor Emeritus, Southern University Agricultural and Extension Center, co-authored a paper entitled "Expansion of meat rabbit projects in disaster-stricken Haiti" presented at the 2011 American Dairy Science Association - American Society of Animal Science Joint Annual Meeting in New Orleans July 13.

Following the recent devastating earthquake in Haiti in January of 2010, humanitarian efforts have been made to expand small-scale rabbit farming enterprises to over 1,000 resettled rural families. The rabbit program was initiated by Dr. McNitt in the mid-90s. The objective of the current study was to evaluate rabbit program status,

based on a USAID consultancy visit in July-August, 2010.

In the townships of Cap Haitian and Grand Boulage, several farms were visited to determine production status.

In general, farmer enthusiasm toward the project was perceived to be high.

In summary, the article states that the project evaluated shed and cage designs as promoted by the host organization (Makouti Agro-Enterprises; MAE), rabbit health problems associated with pathogens, and feeding. The findings concluded that despite the discouraging present status, good progress has been made since project initiation, and people have accepted the practice of rabbit farming and the consumption of rabbit meat in their diets.

Fatemeh Malekian, Ph.D., Associate Professor, Southern University Agricultural Research and Extension Center and adjunct faculty at Louisiana State University, received the 2011 Elizabeth Fleming Stier Award for pursuit of humanitarian ideals and unselfish dedication resulting in significant contributions to the wellbeing of the food industry, academia, students, or the general public.

Dr. Hollis has been steadily pre-registering M.A. Museum Studies students for the Fall 2011 semester. She has about 25 students pre-registered already. A few more have been accepted but are just not in the computer yet.

Dr. Norma Wolff, Cultural Anthropologist and scholar in the area of African art and healing, is donating a small collection of African art and artifacts to M.A. Museum Studies as a teaching collection. The new MUSE professor, Dr. David Riep is going to bring the art collection to SUNO when he and his family drive down to move to Louisiana for the Fall Semester 2011. Dr. Wolff and Dr. Hollis met when at Indiana University in the late 60's. Dr. Wolff has spoken at SUNO in the past and so is familiar with our campus and emphasis on African and African American studies. She has followed the progress of SUNO's M.A. Museum Studies Program and wanted to help.

College of Business & Public Administration: Dr. Igwe Udeh, Dean Report on Major College of Business Activities: June and July, 2011

Accreditation: On July 19, 2011, CBA received a letter from AACSB International listing the names of the Peer Review Team members who have been appointed for SUNO's initial accreditation visit in 2012. The on-campus accreditation visit will take place from October 21 to 24, 2012. In preparation for this visit, CBA is expected to submit a comprehensive Self Evaluation Report addressing all 21 AACSB accreditation review standards by April 2012.

Interior and external finishing touches are ongoing for the new College of Business & Public Administration Building as of July 27, 2011 at SUNO's Lake Campus. The contract for the Building was awarded to Stallings Construction Co (Mike Stallings, President) on March 31, 2010, at a cost of \$3,365,400. Ground was broken on March 24, 2010. The building is to be completed by summer 2011. CBA faculty and staff plan to start moving into the new building by the second week of July 2011.

Pradere Office Products of New Orleans, LA was selected to provide furniture for the new CBA building. The contract was awarded on Tuesday, June 21, 2011. Pradere has already taken steps to ensure that the furniture is delivered on a timely manner.

The CBA Dean, Dr. Igwe E. Udeh, the CBA Coordinator of Accreditation Services, Dr. Frank Martin, and members of CBA's LGCA Committee have been working to refine the learning goals, objectives, and rubrics used to assess several student learning objectives, including ethics, written

and oral communication, based on findings from data collected over the previous two years.

CBA has extended three job offers to faculty applicants to replace some of the faculty members reassigned to units outside the CBA. The hiring process for two of college anticipates hiring four faculty members to meet its instructional, research, service, and AACSB accreditation needs.

Conference Attendance Dr. Igwe E. Udeh, Dean of the College of Business & Public Administration, attended the 2011 National HBCU Business Deans' Roundtable Summit from June 2-4, 2011, in Orlando, Florida. Dr. Udeh was also elected to the Executive Cabinet of the Roundtable as the Secretary of the HBCU Business Deans Roundtable for the 2011-2012 fiscal period during the business meeting of the Roundtable. The Roundtable is made up of the deans and directors of business programs from over 100 HBCUs in the United States.

Dr. Igwe E. Udeh served as Facilitator for the "Sustainability in Business Schools" session on Saturday, June 4, 2011 during the 2011 National HBCU Business Deans' Roundtable Summit, in Orlando, Florida. The presenter was Dr. Robert Barrett, Dean, College of Business, South Carolina State University. The session focused on various issues of sustainability facing business schools in general and HBCUs in particular.

Professional Outreach to Students & Community: Dr. Louis Mancuso, Professor of Marketing in the Business

Entrepreneurship Department, coached several CBA students who participated in and competed during The White House Urban Entrepreneur Forum & Entrepreneurship Competition on July 20, 2011. The conference and competition were sponsored by the White House Business Council, the Office of Public Engagement, the Domestic Policy Council, and Xavier University of New Orleans. SUNO's College of Business had three teams competing in the Entrepreneurship Competition: Tonia Simmons-Doakes, MGIS Graduate Student (Doakes Real Estate Investment Company, LLC); Chaz Tanner, MGIS Graduate Student (TC Solar Powered Flatboat Oil Skimmers, LLC); and Nyisha Walton, Business Entrepreneurship Junior (Walton Enterprise Trucking, LLC). The judges were themselves nationally-renown successful entrepreneurs from around the country. SUNO's Chaz Tanner and his company, TC Solar Powered Flatboat Oil Skimmers, LLC placed in the top three out of numerous entrepreneurs from Louisiana and Mississippi that entered the contest.

Dr. Frank Martin, Chair of the Business Entrepreneurship Department, participated in the State and Local Disadvantaged Business Enterprise (DBE) Panel which certifies small businesses as disadvantaged for the City of New Orleans, the New Orleans Sewerage & Water Board, the Aviation Board, and Caesar's (formerly Harrah's) Casino in June 23, and July 20, 2011.

The meeting was held at Southern University at Baton Rouge (SBIR), on June 21 and 22, 2011. This was our fourth meeting. During this meeting the group narrowed down our strategies to meet our five main objectives. Mr. John Matthews, Executive Director, LED Small Business Services. was a guest at the meeting. The group briefed him in general on the goal of this State -Wide Southern System Coalition. Mr. Matthews also presented to the group the overall focus and direction of LED as it relates to small business services state wide.

The ultimate purpose of the Southern System Small Business Coalition is to develop a program that would coordinate across the state work being done by Southern University in Baton Rouge, Shreveport, and New Orleans campuses, regarding business development and sustainability. Through this undertaking, we hope to improve/expand/support each campus's efforts across the state.

Louisiana Workforce Commission Incumbent Workers Training Program Social Service Contract





Chancellor Freddie Pitcher, Jr., Featured Prominently Among Speakers at the Recent Funeral Service for Pioneer Jurist Ralph Eric Tyson

Chancellor Pitcher reflected on his 40-year friendship with Judge Tyson. His rise from humble beginnings to prominent jurist mirrors that of Chancellor Pitcher. The two met in 1972 when Pitcher, a Southern University Law Center student enrolled in summer classes at the Paul M. Hebert Law Center at LSU.

"Ralph was the only African-American student at the Law School," Pitcher said.

"Together that summer, we made up a total diversity population of two."

Pitcher shared his favorite memories of his friend, from their early days with the State Attorney General's office to Tyson's sense of humor during "high teas" at their first practice on Plank Road in Baton Rouge.

Chancellor Pitcher went on to recall that he and Ralph "hold the distinction of being the first African Americans to represent the State of Louisiana in a criminal case in East and West Feliciana parishes as prosecutors. He said, we were assigned the prosecution of an attempted escape case from Angola that was to be tried in St. Francisville. We prepared our witnesses, and finally got notice of a preliminary hearing. Off we went on the hearing date. It was our very first court appearance. There we were, brand new lawyers, wearing brand new suits with new brief cases. When we walked into the court—with our new lawyer swagger, the Judge yelled to the deputy, "Seize those men." We froze in our tracks. Here it is, our first day in court and getting on the wrong side of the judge already.

John Sinquefield, our Section Chief, stood up and said, "Judge, they are Assistant Attorneys General," to which the Judge replied, "They are what?" Sinquefield again said, "They are Assistant Attorneys General." We were then invited into the courtroom. Moreover, when we swung open the courtroom door, we didn't realize that we were walking into a hearing that was closed to the public. Making this day even more interesting was the fact that during the hearing, the Judge could not get it straight as to which side we were representing. The defendant, an African American, was represented by a white attorney. The Judge's world was turned upside down. His confusion escalated each time we made an objection on behalf of the State. He had to take a recess to get things straightened out.

Pitcher continued, Ralph's strong work ethic and penchant for perfection began to take shape as he sparred with the likes of "The Black Nudge", a notorious writ writer from the Louisiana State Prison at Angola. The Nudge would file a writ about almost anything (no 2-ply paper in the restrooms at Angola). Ralph was obligated to file an answer and argue the merits in court. On many evenings, Ralph was left alone in the office library working on a writ response or preparing for oral arguments. One evening, I asked Ralph, why are you working so hard on that case? His response was, "I can't afford to lose to the Nudge – you all would laugh me out of the building." And he was right! That work ethic quickly carried over to the private practice in their law office established on Plank Road in Baton Rouge. They quickly developed a reputation of providing excellent client representation and service.

Judge Tyson fought cancer with a quiet determination, never complaining about his prognosis, several speakers said. "When days were darkest and we went to talk to him, we would leave feeling consoled by him," Chancellor Pitcher said.

Butts earned an A.B. from Syracuse University in Public Relations and Modern Foreign Languages and a J.D. from the University of Florida. She taught Legal Research and Writing for six years at John Marshall. Before teaching, she practiced complex litigation in Atlanta.

Blais holds an A.B. in English from the University of Chicago and a J.D. from Illinois Institute of Technology (IIT) Chicago-Kent College of Law. 

#### "Researching Today for a Better Tomorrow" HBCU-UP Summer Science Research Program Symposium 2011

Southern University at Shreveport Louisiana (SUSLA) was awarded a five-year comprehensive implementation project though NSF-HBCU-UP Program. The objective of the project is to strengthen Sciences, Technology, Engineering and Mathematics (STEM) programs at SUSLA. "We propose to enhance and strengthen STEM curricula, undergraduate research, student recruitment and retention, and faculty professional development" says Dr. Barry Hester, PI/Director of the Program.

According to Dr. Hester, undergraduate research experience is one of the most crucial factors that influence a student's decision to undertake research or academic career. Students interested in STEM careers need to develop these skills and there is no better way than through hand-on training on research. The primary focus of the STEM-undergraduate research experience program will be to encourage and facilitate the pursuit of research careers. A second purpose of the program is to assist students with interests in other science-based careers so that they gain an appreciation for the nature of research. Additional objectives include: 1) introducing students to a diversity of science and technology research, 2) preparing students for independent research, 3) fostering self-confidence and team-working ability in observation, recording, and interpreting

data, 4) providing close working interaction between the faculty and student, leading to excellent mentorship opportunities, 5) providing opportunities for oral and written communications of research findings, 6) providing career guidance and information about scientific professions in academia, government, and industry, and 7) assisting students in meeting financial obligations.

The STEM enrichment activities at SUSLA are certainly to increase student awareness of high quality research in these areas. Eleven (11) students, Taylor S. Brooks, Annie P. Clark, Ellington D. Dias, Elizabeth Dyas, Kristen D. Gilliam, Anthonia Q. Hall, LonTravia B. Morris, Charles E. Newton, Aterica Pearson, Andrenique Robinson and Josie C. Young. participated Thursday, July 28, 2011 presenting their Summer research work. Student were asked to present their research orally (power point presentation). Oral presentations used the follow the format of a professional scientific meeting. Mentors for the Summer Program were Dr. John Alak, Dr. Joseph Orban, Dr. Tracy Reed and Dr. Barry Hester. This symposium was open to the public, mentors, faculty and mentors from the partner institutions. Written reports adhered



to scientific publication format and were reviewed as described in the program evaluation techniques. The existence of STEM projects on the SUSLA campus community will provide students with wide exposure to become familiar with research programs during the academic years. SUSLA has established partnerships with other institutions, federal labs and private companies who will offer the students opportunities to participate in research during the summer. In the past, scientists from these institutions have been very supportive of our undergraduate enrichment

programs. They have come to the SUSLA campus to present seminars, to extend their support and have invited our faculty and students to visit their laboratories. We strongly feel that the SUSLA STEM enrichment activities will foster students' scientific interest in the pursuit of research careers in the STEM areas.


SUSLA's School of Nursing Pinning Ceremony - Summer 2011

#### "From GED's To College Degrees"

The "From GED's To College Degrees" is a new innovative program at Southern University at Shreveport (SUSLA) that moves more American adults through the postsecondary education pipeline. GED holders account for a large proportion of adults who are omitted from the postsecondary education system.
