#### Addendum

Mayor Mitch Landrieu welcomed the members of the Board and Administrators to New Orleans and offered his congratulations on the successful joint effort between the University and its widespread constituencies which helped to defeat the proposed legislation to merge SUNO and UNO during the recent session.

Mayor Landrieu provided an overview of issues prevalent in New Orleans community, especially, in the African American community; i.e., high rate of crime, at-risk students, and incarceration of African American males. The mayor suggested this would be an ideal time for the Board and Administrators to consider and possibly redefine SUNO's future mission in higher education into that of a Model Urban University primarily addressing the crucial educational needs of the underserved New Orleans populace. He advanced the idea of a collaborative effort between SUNO, UNO and Delgado to achieve this end.

President Mason reported on the development of a plan by Southern University, in collaboration with other higher education institutions in New Orleans, to establish "*The Honore' Center for Undergraduate Student Achievement.*" The plan offers "a focused learning approach to strengthen the role of public higher education in building a Greater New Orleans."

Board Member Lawson announced that funds in the amount of \$3 million were earmarked by the Louisiana Legislative Black Caucus during the recent session to fund programs for troubled youth; \$500,000 of that amount will be used to provide financial support for The Honore' Center.

#### A. Reappointment and Sabbatical for Dr. Kofi Lomotey, SUBR

Considerable discussion ensued relative to the Administration's proposed annual employment compensation of \$120,000 for Chancellor Kofi Lomotey's reappointment as a tenured faculty member in the College of Education, SUBR, effective July 1, 2011. Those opposing the proposal cited the campus' pending budget cuts and ongoing dire financial posture as the basis for their position.

Supporters of the recommendation referenced Dr. Lomotey's experience in higher education, including his role as Chancellor; the proposed salary for his new position equaled the highest paid faculty member in the College, but was less than the amount paid to former Chancellors upon their reassignment to faculty positions, and that Dr. Lomotey has agreed to assist the incoming Chancellor while he was on the requested sabbatical leave.

On motion of Mr. Bell, seconded by Atty. Bell, the Committee approved, and so recommends to the Board, the reappointment of Dr. Kofi Lomotey as a tenured faculty member in the College of Education at SUBR, effective July 1, 2011 at a annual salary of \$120,000; and, further approved, and so recommends to the Board, Dr. Lomotey's request for a sabbatical, effective for the Fall 2011 semester.

Motion carried unanimously.

The Committee was advised that incoming Chancellor, Dr. James Llorens, concurred with the Administration's recommendations relative to Dr. Lomotey.

This agreement may be extended for a fourth year (July 1, 2014 – June 30, 2015) if the Chancellor satisfactorily meets the duties in Section 2 of the Agreement during the first two years of the initial term. Upon the recommendation of the System President, the Board, in its sole discretion, shall provide notice of intent to extend this agreement by April 30, 2014.

The Chancellor will be appointed as a full professor with tenure in the Nelson Mandela School of Public Policy at Southern University and A & M College.

Dr. Ray L. Belton and Dr. Dan Kaseje, Vice Chancellor, Great Lakes University

Southern University at Shreveport Louisiana (SUSLA) and the Great Lakes University of Kisumu (GLUK) in Kenya, East Africa signed a Memorandum of Understanding (MOU) on June 20, 2011 at the Shreveport campus. The MOU is for the two universities to work collaboratively to establish a training program in poultry science at GLUK that would lead to training of students in Poultry Science and Management. The MOU was jointly signed by the SUSLA Chancellor, Dr. Ray L. Belton and the Vice Chancellor of GLUK, Dr. Dan Kaseje. Dr. Joseph Orban, a Distinguished Professor of Biomedical Sciences and Director of Biomedical Research Development, will provide expertise and leadership over the program. The development of the curriculum for the program will include programs at the certificate, diploma, bachelors and masters degree levels. The curriculums will not only embrace poultry

"It's very important not only as an academic program but also in producing graduates that are prepared to be able to expand the economic of our country," says Dr. Dan Kaseje, Vice Chancellor, GLUK in Kenya." science courses but include general core education and science courses as well as supporting courses in business and financial management. As soon as arrangements are completed, students from Kenya can register for business courses being taught online at SUSLA and Dr. Orban will travel to set-up in-class courses in poultry science at the Kenyan University.

The development of the curriculum in Poultry Science at GLUK is unique in that the University will be the first and only one to offer degree programs in Poultry Science in Kenya and the whole of East Africa. Initial poultry projects with GLUK were sponsored by Winrock International of Little Rock Arkansas. Winrock International is a nonprofit organization that works with experts in different fields in the U.S. and people around the world to increase economic opportunity, sustain natural resources and protect the environment. SUSLA has worked in the past with Winrock on international development projects involving poultry production and feed formulation in Nigeria, West Africa and Bangladesh, Asia.


the Heat Louisiana Style."



## **Chancellor's Monthly Report**

### SUNO's On-Campus Business Incubator approved by the Board of Regents

The Louisiana Board of Regents approved the University's request to build a \$3 million On-Campus Business Incubator facility on Thursday, June 23rd during its monthly meeting in Baton Rouge. The building is entirely funded from federal sources, and should be completed within two years. The facility will allow for a seamless interaction between classroom education and real-world entrepreneurs. In addition to the space to be rented out to the entrepreneurs, the building will contain faculty and staff offices as well as meeting rooms to be used by tenants and students. The incubator will be located on the Lake Campus, close to the new College of Business & Public Administration building.



The facility is expected to pay major dividends, academically for SUNO. It will create an ideal environment for cross-disciplinary learning and entrepreneurial collaboration between business majors and students from such majors as Social Work, Education, Substance Abuse Counseling, Criminal Justice, and the Natural Sciences who wish to go into business in such areas as mental health, child protection, assisted living, group homes, daycare centers, adult literacy, inmate-to-society transition programs, chemical dependency education, and drug abuse counseling. The facility will also support the College of Business & Public Administration's AACSB accreditation plan by allowing the faculty to deliver more practical teaching, research excellence, community service, and meet other AACSB and SACS accreditation requirements.

The approval of the incubator will also benefit the New Orleans area as America's new breeding ground for entrepreneurship. The August 2009 issue of <u>Entrepreneur</u> magazine declared the New Orleans Metro area as one of the cities with the fastest growth in entrepreneurial activities. Based on the number of individuals and organizations that participated in our recent business workshops, over 1,000 potential small businesses in the New Orleans metropolitan area could benefit from and/or use the services of the proposed on-campus small business incubator facility.

### **Clark Hall Demolition**

The Louisiana Office of Facility Planning & Control this week granted approval for the demolition of Clark Hall (the education building). Upon completion of the bidding process, plans call for the demotion to occur within the next few months.

An inspection of Clark Hall noted the need for asbestos abatement and subsequent demolition. Funding from FEMA that was earmarked for SUNO's rebuilding will be used to construct a new building in accordance with the University's master plan.

#### SUNO selected as Louisiana's safest campus for second year in a row

TY AT NEW ORLEANS

For the second year in a row, Southern University at New Orleans has been ranked #1 in campus safety with a 98.18 safety rating among Louisiana colleges and universities by StateUniversity.com. The University is ranked #19 in the U.S. by the web site, up from 20th in 2009. The campus safety report is based on incidents reported by campus safety officials.

As seen at http://www.stateuniversity.com/rank\_by\_state/safety\_score\_rank/LA.html, SUNO recorded .38 burglaries and 2.27 larceny-theft incidents per 1,000 students. Other categories considered were aggravated assault, arson, forcible rape, murder, robbery and vehicle theft. According to StateUniversity.com "colleges and universities ranked for campus safety on a scale that accounts for severity of a crime as well as frequency of crime." SUNO is the highest ranked four-year HBCU in America.

### SU Ag Center Personnel Attend USDA/NIFA Annual Meeting in Alaska

he United States Department of Agriculture/National Institute of Food and Agriculture (USDA/NIFA) held its 2011 National Extension and Research Administrative Officers' Conference hosted by the University of Alaska at Fairbanks, May 22-26 in Anchorage, Alaska. The conference targeted personnel involved in administering USDA/NIFA funded programs - those who prepare program reports on grants and formula opportunity funds, human resource issues. diversitv/civil rights, and those preparing required plans of work and annual report of accomplishments and results on Hatch. Smith-Lever. McIntire-Stennis, and other related funds. This year's conference was really crucial given the projected severe federal budget reductions for the coming fiscal year. All land-grant institutions were represented at the conference which was attended by more than 550 individuals from the United States and the territories. Several officers and staff from various units of the USDA/NIFA were on hand to answer questions from participants.

Dr. Kirkland Mellad, vice chancellor for research, led the team from Southern University Ag Center participating in the conference.

The conference provided information on changes in USDA/NIFA policy and procedure, as well as updates for the coming year. With the uncertain budget situation for FY 2012, the restructuring of USDA/NIFA and the appointment of an interim director, this year's conference was particularly essential for the administrators and staff who oversee and report on federal funds appropriated for USDA. NIFA officers and staff, who manage awards, emphasized the need to abide by the terms and conditions of the awards especially by using grant funds for the specific purpose intended, and to advance the mission of the United States Department of Agriculture/ National Institute of Food and Aginstitutions riculture. Partner were urged to be ready for audit whenever required by the Federal Government.

Presenters at the conference clarified some lingering issues about the revised NIFA Priority Areas: Global Food Security; Childhood Obesity; Climate Change; Sustainable Energy; and Food Safety. They also discussed extensively the need for annual reports that are outcome-based; these reports receive a lot of attention from federal authorities such as the Office of the President through the office of Management and Budget, Congress, and the Office of the Inspector General, USDA.

Other presenters shared their knowledge on best practices relating to grants submission through grants.gov, impact reporting, networking for effective performance, management in the midst of dwindling resources, diversity and building cultural competences, and such.

### SU Ag Center Kicks off the MISS-LOU Experiential Learning Garden

The MISS-LOU Experiential Learning Garden Summer Programs began June 1, and concludes on July 21st.

The garden has two locations: The first is located on the Horticultural Farm behind the SU Ag Center main building. This program serves youth ages 5-18, and meets Tuesdays and Thursdays, 8 am until noon. The second location is in Zachary on Rollins Road, behind the Men's Club and is conducted in collaboration with the Zachary Men's Club.

During normal class sessions in the first location, participants pull weeds, plant seeds, water and harvest produce. Youth are taught ageappropriate garden curriculum to encourage development skills associated with community gardening. "The garden can already be tagged a success because the kids ate sautéed Zucchini Thursday ... and LOVED IT!" said Stephanie Elwood, extension associate/Community Gardener.

In the Zachary location, the program meets every Monday and Wednesday. On Mondays, 5-7 pm is harvest time for the food pantry; and Wednesdays, 8 am until noon is spent tending to the garden and participating in lessons from an ageappropriate garden curriculum. This program reaches out to students in grades 8-12. A cooking class is scheduled and will be taught by Fatemeh Malekian, associate professor, nutrition, and Mila Berhane, senior research associate.

In Louisiana, the program is dubbed "MISS LOU: Connecting Kids and Community Project" because it serves families in Mississippi and Louisiana through partnerships with Mississippi State University, Alcorn State University, and Louisiana State University. The project primarily targets youth of military families, although civilian youth and adults are welcome to join on a voluntary basis. The program is free and continuously open for families and youth to register and participate. Tiffany Franklin and Stephanie Elwood are coordinating the programs.

Both programs are funded by the USDA/NIFA and the Department of Defense through the Military Community, Family and Youth Extension Project.

Breastfeeding train-theworkshop trainer themed "Grow and Glow in WIC" was held at the Southern University Ag Center, June 7. The workshop was a collaborative effort between the Southern University Ag Center and Louisiana Department of Welfare of Infants and Children (WIC) and included staff from the SU Ag Center, WIC, and other breastfeeding organizations throughout the state of Louisiana.

The motivational training session provided an overview of successful strategies implemented across the U.S. to create a breastfeeding-friendly community. The training explored the use of social marketing principles to plan an effective breastfeeding promotion campaign, principles behind USDA's WIC National Breastfeeding Promotion program, Loving Support<sup>®</sup> Makes Breastfeeding Work, and creative strategies to support breastfeeding families, including educating clients, gaining buy-in from staff, healthcare providers, and the community, and using public awareness channels.

Studies show that breastfeeding's protective effects continue well into adult life. SU Ag Center staff will begin collaborating at the local level with WIC agencies to emphasize this important message to our clientele.

The training was organized by De'Shoin York Friendship, assistant specialist, nutrition and Fatemeh Malekian, associate professor, nutrition, with funding from an Ag Center mini grant. The training session was led by a nationwide trainer, Kendal Cox of EveryMother, Inc.

### **Faculty, Staff Activities and Accomplishments**

Aubrey Williams, associate area youth agent, Southwest Center for Rural Initiatives, taught in the St. Landry Parish School Board Career Pathway Camp, on June 6 and 23. This camp gives students the opportunity to experience different types of careers through field trips, classroom discussions and demonstrations. The students that attend this camp earn a half Carnegie unit credit for high school graduation. Due to the large number of applicants this year, two camps were scheduled. These two camps attracted sixty students. The Camp location was at the T. H. Harris Technical College Campus in Opelousas.

Williams performed a hands-on water quality demonstration at the camp to introduce 8<sup>th</sup> graders to a career in science. This demonstration was chosen because of the current events of opening of the

Angela Myles accompanied 24 participants in the Youth Educational Support program on a Science Enrichment trip to the Laser Interferometer Gravitational-Wave Observatory (LIGO) in Livingston Parish, June 29. LIGO Morganza and the Bonnie Carrie Spillways creating flood zones that impacted agricultural farmland.

For this particular demonstration. the class was divided into six groups of five. Each group was shown five tests using two techniques, hand-held electrical probe and indicator strips. The tests performed were: pH, salinity, temperature, total solubility of solids, and water hardness. First, each test was demonstrated to the class and then each group performed its own test using assigned water sample. Then, each test result was explained on whether it was good or bad based on the value for that test. After the demonstration, students were surprised to learn that the water they drink is safe even if it smells or tastes bad.

is a facility dedicated to the detection of cosmic gravitational waves and the harnessing of these waves for scientific research. It consists of two widely separated installations within the United States, operated in unison as a single observatory. When fully established, this observatory will be open for use by the national community and will become part of a planned worldwide network of gravitational-wave observatories.



This event brought together 1,400 participants from across Louisiana and provided an opportunity for 4-H members to learn about the legslative process. Following the assembly, the group toured the Capicol and experienced the legislature at work. They also viewed the 4-H exhibits and displays set up in the obby featuring Louisiana 4-H programs.

**Myles** chaperoned 30 youth from St. Helena Parish in grades 4-6 to the 4-H Louisiana Summer Camp. The camp strives to develop a variety of life skills related to Head, Heart, Hands and Health. One of the most important skills children earn from the camp is selfsufficiency. That means they learn now to survive four whole days on their own. At the 4-H University, Louisiana 4 -H'ers competed for best in the state in more than 40 events ranging from plant identification, photography and computer simulation to speechmaking and fashion design. In addition, 300 students took part in the non-competitive learning event called "Clover College," which included seven hours of instruction over the three days. Participants were introduced to aspects of life that college students experience on a daily basis.

4-H members who were 13 years old before January 1 were eligible to attend 4-H University held on the campus of LSU in Baton Rouge. 4-H U gives youth the opportunity to meet 4-H'ers from different parts of the state and compete for trips and prizes through a variety of project-area contests.

Myles also led a group to the Southeast Region 4-H Challenge Camp designed for 7-8<sup>th</sup> grade club members from across the state. The camp was located at Tickfaw State Park in Livingston Parish.

### Chancellor Pitcher Featured in Documentary

Chancellor Freddie Pitcher, Jr., was featured in the recently premiered documentary, "Remembering a Forgotten First: The Story of Charlie Granger." The 52-minute film was screened Saturday, June 11, in the SU Smith-Brown Memorial Student Union, during the annual SU Sports hall of Fame Banquet. Granger, a former NFL player, has been chair of the Hall of Fame Committee since 2003. The 2011 Hall of Fame inducted 11 new members.

#### Civil Rights Activist Gone But Always To Be Remembered

The recent passing of the Rev. B. Elton Cox on June 11, 2011, at the age of 79, gives cause to reflect on yet another civil rights giant who has left an indelible mark on civil rights legal history prompted by a demonstration in Baton Rouge.

Rev. Cox was jailed 17 times during the civil rights movement, but it is his legal case, <u>Cox v.</u> <u>Louisiana</u> (1965), that originated from a peaceful protest by Southern University students, that he led, for which he is most remembered. The case, taught in law schools throughout this country, sets precedence in freedoms of speech and assembly, secured by the First Amendment of the U.S. Constitution.

Cox believed that nonviolent action was the best way to effect change, despite the fact that his peaceful demonstrations as Field Secretary for the National Association for the Advancement of Colored People (NAACP), and the Congress of Racial Equality (CORE), brought violent reactions, arrests, and jail time. He was among the Freedom Riders, black and white, who challenged racial discrimination through the South on a trip from Washington, D.C., to New Orleans.

#### Law Review Authors Recognized Nationwide

Articles written by SULC Law Review members continue to gain recognition nationwide, Prof. Gail Stephenson, Southern University Law Review adviser, noted recently.

Mekisha Smith's article on grandparent visitation was cited in New York Children's Lawyer, a publication of the Appellate Division of the Supreme Court of New York. Candice Rodgers's article on student searches was cited in an article in the Journal of Law and Education.

In the Law Review Workshop this year, Stephenson encouraged students to upload their articles to the Social Sciences Research Network (SSRN). "The results have been so positive that next year I am going to make publication through SSRN a class requirement," Stephenson said.

Articles by Lanzi Helms, Sherry Cannon, and Ashley Jyles have made SSRN's top ten downloads list. Sherry Cannon was interviewed by an Associated Press reporter as an expert on the legal issues connected with sexting, after the reporter read her article on SSRN.

#### Students Participate in Equal Justice Works 2011 Summer Corps Program

Four SULC students are participating in the 2011 Summer Corps Program sponsored by Equal Justice Works.

*Chrishauna Johnson, Patrice Maddox, Victoria Minor, and Crii Spears-DeLeo were chosen from among a record 1,898 applicants this year, making the selection process extremely competitive.* 

This year's Summer Corps class represents 163 Equal Justice Works law schools. These law students will receive a \$1,132 Americorps education award upon completion of service at a nonprofit organization. Members provide critically needed legal assistance to low-income and underserved communities around the country. In addition, Summer Corps members gain first-hand experience and legal skills in areas such as client intake, individual representation, research, and writing.

Summer Corps members are engaged with a broad range of issues, including civil rights, community economic development, death penalty, disability rights, housing, domestic violence, education, public benefits, and workers' rights.

#### SULC Minority Law and Research Institute

The 11<sup>th</sup> Annual Minority Law and Research Institute, designed to introduce underrepresented students to legal studies and to encourage consideration of careers in the legal profession, ran June 20-July 1 at A.A. Lenoir Hall.

The two-week program helps to raise students' awareness of legal careers and encourages them to set high expectations for academic achievement, according to Prof. Donald North, Director of the Clinical Education Program.

Institute participants are presented legal information and case studies, hear lectures from law professors and trial attorneys, and participate in mock trials, as well as conduct research and complete projects in law.

Since the Institute has been conducted on the SULC campus, in conjunction with the Aunt Berta's Education Foundation, more than 300 minority high school students from Louisiana, Alabama, Georgia, Mississippi, North Carolina, and Virginia have participated.



The 2011 Summer Pre-Law Program, an intensive four-week program for incoming students to help them get acclimated to the legal education environment, is underway through July 29 at A.A. Lenoir Hall.

The theme for 2011 is "Set a Course for Success: A Passion for Learning, Impeccable Character and A Commitment to Excellence." More than thirty percent of the incoming class is participating this summer and there are students on the waiting list, according to Berryl Gordon-Thompson, Associate Vice Chancellor for Academic Support Programs.

"Through instruction in the substantive first-year courses (Torts, Contracts, and Basic Civil Procedure), students have the opportunities to analyze and synthesize precedent, interpret statutes, construct policy arguments, and write and speak with clarity and precision," Gordon-Thompson said. "Pre-law students are also introduced to legal skills, emphasizing legal writing and legal analysis through a skills component of the program," she added.

Castille, Jr., at the Annual CLE Palooza/Pro Bono Awards Reception, Thursday, June 23, at the LSU Paul M. Hebert Law Center.
