A. FINANCIAL STATUS REPORTS, SU SYSTEM ENTITIES

General Fund Budget projections, as of February 29, 2012, were provided for the Committee's information. A copy is on file in the Board's office and website.

B. PRELIMINARY ANALYSIS OF EXECUTIVE PROPOSAL FOR SU SYSTEM ENTITIES

The report was presented by System Vice President Appleton. Highlights follow:

- A decrease in FY 2012-13 State Appropriations to Southern University is anticipated to be \$6,521,390 or 11.3%; and a decrease of \$7,722,442 or 5.6% in SU's total operating budgets when compared to FY 2011-12.
- The FY 12 mid-year cut of \$2,937,742 is annualized for FY 13.
- FY 12 carry forward funds of \$6,041,233 have been removed for FY 13
- Estimated unfunded mandate costs for FY 2011-12 is \$3,548,772. Estimates are not available for FY 2012-13.
- Should the SU campuses fail to meet their respective La GRAD Act targets, at risk are tuition increases that are included in the FY13 budgets; and, funding formula performance allocations of \$6,437,766.

Discussion ensued regarding efforts to date of the Administration to --

- take advantage of the Declaration of Financial Exigency at SUBR in order to make programmatic changes and personnel reductions to address continuing budget reductions.
- develop a plan of action to address campuses' performance goals, including seeking relief from the State Legislature from future budget reductions and penalties should the University fail to reach the La GRAD Act targets.
- address low student retention rates of 1st time freshmen by incorporating exit interviews to determine students' reasons for leaving the University; and, to provide resources to address their reasons.

increase graduation rates

A full report on the items above is to be given to the Committee at its April meeting.

The Administration was also requested to forward to Board Members 1) a copy of the FY 2012-13 Executive Budget proposals and the Board of Regents allocation recommendations, as presented by Vice President Appleton; and 2) information from the Chancellor, as requested by Board Member Clayton, relative to the SUBR's current student retention rate and progress reached in meeting its La Grad Act targets.

C. EDUCATIONAL ASSISTANCE SCHOLARSHIP PROGRAM POLICY, SUS

The Committee discussed the proposal submitted by Board Member Sumner to give authority to the Chancellors to award scholarship funds from the sale of La. Prestige License Plates. Under the present policy, the funds are administered at the Board and System level.

Several members spoke in support of the current policy. When queried, Chancellors indicated no opposition to the current policy. Chancellor Llorens indicated that his only concern was that SUBR students have access to the scholarship funds.

The item was withdrawn by Mr. Sumner.





- SkyMail +Plus: The SkyMail+Plus is our new Cloud-based email and applications computing platform hosted at Microsoft.
- <u>MySUSLA IntraNet:</u> MySUSLA is our new employees' Intranet Website designed for university internal communications. The Intranet requires user login and is accessible on campus.
- <u>Virtual Private Network (VPN):</u> SUSLA VPN provides employees highly secured remote access and site-to-site connections to data, voice, video, and application systems.
- <u>Voice-over-IP (VoIP) Telephony</u>: ITC is deploying the latest generation in Voice-over-IP telephony applications to facilitate workplace communications, efficiency, and productivity distance toll surcharges typically associated with conventional analog telephone systems.
- <u>Modular Object Oriented Dynamic Learning Environment (MOODLE):</u> Technical development efforts are continuing towards transitioning from Blackboard to MOODLE. Currently, all courses available in BlackBoard have been imported into MOODLE.
- <u>Campus Security and Emergency Preparedness</u>: The expansions of the university physical security apparatus (networked video surveillance technology, AxisTV, and FirstCall) are ongoing. Assumptions Built Into FY 2012-13 Operating Budget

The 2012-2013 Operating Budget is developed based on 16 assumptions.

On October 28, 2012, the Southern University Board of Supervisors approved a declaration of financial exigency on the Baton Rouge Campus. This approval allows the university to furlough all employees earning \$30,000 and above for the 2011-12 fiscal year and to reduce faculty, staff and administration for the 2012-2013 fiscal year.

The following are assumptions built into the FY 2012-13 proposed budget. For any assumption that does not hold true as we move through the budgeting process, we will make appropriate adjustments.

Assumption 1: The University Must Submit a Balanced Budget

The University will submit a balanced budget for 2012-2013 fiscal year and will operate within a balance budget until the fiscal year close.

Assumption 2: Projected Enrollment Decrease of Approximately 200 Students

The University is projecting a decline in student enrollment for the 2012-2013 fiscal year of approximately 200 students.

Assumption 3: Implementation of (10%) Tuition Fee Increase

The University will implement the 10% tuition fee increase consistent with the LA GRAD ACT.

Assumption 4: Implement Out-of-State Fee Increase

The University will implement an out-of-state fee increase consistent with the LA GRAD ACT.

Assumption 5: Formula Relief in the Amount of \$961,480

The University will receive Formula Relief in the amount of \$961,480.

Assumption 6: Reduction in State General Funds of \$ 2.0 Million

The State General Funds will decline approximately \$2.0 million dollars (1/2 worse case) as a result of a Contingency Fund Gap (Retirement) in the Governor's Executive Budget.

Assumption 7: \$1 Million in Annual Fund Support

The University will generate \$1 million in revenues from annual fund support for the 2012-13 fiscal year.

Assumption 8: Increase Revenues by \$250,000 through Additional On-line Course Offerings

The University will generate an additional \$250,000 through additional on-line course offerings.

Assumption 9: Discontinue 10% Furlough for all Employees.

The University will discontinue the implementation of a 10% furlough for all employees.

Assumption 10: SUBR Unfunded Mandates of 2.2 Million

The University's unfunded mandates for the 2012-2013 fiscal year is estimated to be approximately \$2.2 million.

Assumption 11: Increase Chancellor's Scholarships Offerings by \$100,000

The University will increase the Chancellor's Scholarships by \$100,000.

Assumption 12: Civil Service Step Increase not funded

The University will not award any merit increases to Civil Service employees for the 2012-13 fiscal year.

Assumption 13: No increase in Subsidization of Athletic Program

The University will not increase the general fund subsidy for the Department of Athletics during the 2012-2013 fiscal year.

Assumption 14: Allocate \$250,000 for Marketing

The University will allocate an additional \$250,000 for marketing to increase enrollment.

Assumption 15: Allocation of Funds for Specialized Accreditation

The University will allocate additional funds for specialized program accreditation.

Assumption 16: Implement Academic and Administrative Restructuring Plan

The University will implement an academic and administrative restructuring plan as a part of the overall University Retrenchment Plan.

Our plan is to survive FY 2012-13, stabilize during FY 2013-14, and lay the foundation for the future in FY 2014-15. By 2020, SUBR will be a stronger contributor to the state's economy and to the wellbeing of the citizenry of Louisiana. However, in order to do so we will need assistance from the Board of Regents and the State. Specifically, the following:

- 1) Temporary relief (should we need such relief) regarding compliance with conditions for SUBR's continued participation in the GRAD Act.
- 2) Temporary relief from reductions in formula allocated appropriations.
- 3) Temporary relief relative to having formula funding driven by end of semester enrollment versus 14th day enrollment
- 4) Temporary admissions criteria relief

5) Temporary financial assistance to off-set the costs associated with unfunded mandates.

SIGNIFICANT ACCOMPLISHMENTS/ACHIEVEMENTS

Chancellor Llorens makes pitch for students in Turkey



Imagine several dozen or more international students from Turkey enrolling at Southern University in the fall. It could happen and, even more could be arriving on the Baton Rouge campus in a year or two.

Chancellor James L. Llorens and Professor Osman Kandara recently returned from a fact-finding and recruiting mission to Turkey where they met with education officials from several cities to discuss the possibilities of undergraduate and graduate students attending Southern. Student and faculty exchanges between Turkey and SU were also discussed.

"There is a good possibility that we will be able to make this work," said Chancellor Llorens. "We're excited about the opportunities and the Turkish education officials are very interested in what we have to offer."

The Chancellor said the relationship building with Turkey is part of the University's new, more aggressive student recruitment campaign.

The trip, January 13 through January 21, included Chancellor Llorens, Professor Osman Kandara and Professor Eugene Kennedy of LSU. Dr. Kandara, a graduate faculty member in the Department of Computer Science, is one of the two professors who have been advising Turkey's Higher Education Council (YOK in Turkish) sponsored visiting scholars at Southern. The other is Dr. Patrick Mensah in mechanical engineering. Dr. Kamran Abdollahi in urban forestry has also invited a YOK sponsored scholar pending visa approval. There will be more YOK sponsored visiting scholars on the campus in the upcoming months.

YOK is the central governing body of all universities in Turkey.

The SUBR Chancellor also met with the officials from the Measurement, Selection, and Placement Center (OSYM in Turkish), the sole governmental agency in charge of administrating the central admission processes to all Turkish universities. Chancellor Llorens also said they agreed in principal with OSYM to study the possibilities of admitting Turkish students at Southern through its centralized admission processes.

The Chancellor signed agreements and memorandums of understanding with Istanbul Sabahattin Zaim, Istanbul Commerce, Sakarya, and Bursa Technical universities. He invited chancellors from those schools, along with Abant izzet Baysal, Karabuk, and Marmara Universities to Baton Rouge.

Among others invited were the congressman, Dr.Ibrahim Korkmaz, the Executive Council Member of the Turkish Higher Education Council, Prof. Dr. Durmus Gunay, and the administrators at Oncu, a private high school in Ankara.

Officials at Oncu are studying the possibility of sending the school's high school graduates to Southern with assigned supervising teachers, Chancellor Llorens said. There could be between 20 and 30 students involved.

Dr. Barbara W. Carpenter, the Dean of International Education, and Dr. Osman Kandara will coordinate the educational itinerary for the visitors.

Chancellor Llorens also said they agreed in principal with Marmara University to study the possibilities of a student exchange program for dual degree diploma between Southern's computer science program and that Marmara's computer engineering program as a pilot project.

"The importance in all of this is that we will continue talking with Turkish education officials about the mutual benefits of us working together," said the Chancellor. "This could be a major, long-term educational partnership.

SU professor earns Andrew W. Mellon funded scholarship

Rachel Vincent-Finley, an assistant professor in the Department of Computer Science, has been awarded a national 2012 Career Enhancement Fellowship for Junior Faculty. The Andrew W. Mellon Foundation funds the fellowship.

The fellowship, administered by the Woodrow Wilson National Fellowship Foundation, is awarded annually to 20 junior faculty nationwide within the teaching fields of physical sciences, social sciences and humanities.

The award is designed to assist talented junior faculty in pursuit of scholarly research with a goal of increasing the presence of faculty who are "committed to eradicating racial disparities in core fields in the arts and sciences."

The Career Enhancement Fellowship Program provides one year of financial support, mentoring, and a fall retreat for participants. Its goal is to "aid the scholarly research and intellectual growth of fellows."

"Receiving this fellowship provides me the resources to promote the development of research at Southern University and it will enrich my teaching capabilities," Dr. Vincent-Finley said.

Dr. Vincent-Finley received a doctorate in Computational and Applied Mathematics from Rice University and completed a post-doctoral appointment in the Institute of Molecular Design at the University of Houston.

Prior to joining the faculty at Southern in 2009, Dr. Vincent-Finley was a Visiting Assistant Professor of Mathematics at Tulane University. At Southern, Dr. Vincent-Finley is a Louisiana Optical Network Initiative (LONI) fellow and serves on the LONI Management Council.

During the 2012-2013 academic year, Dr. Vincent-Finley will engage in research activities that will support the development and sustainability of her research program at Southern. Her general research interests include numerical methods and mathematical modeling with research applications to molecular biophysics and materials science.

The research applications to materials science include research in support of the Laser Interferometer Gravitational Wave Observatory (LIGO). This research seeks to build computational models of the coatings material based upon first principles calculations and experimentally determined features of the system in order to predict materials properties and performance.

Founded in 1945, the Woodrow Wilson National Fellowship Foundation is an independent, nonprofit organization dedicated to the encouragement of excellence in education through the identification of critical needs and the development of effective national programs to address them.

Physics majors earn prestigious summer research fellowships



Two Southern University physics majors have been awarded prestigious summer research internships for 2012.

Senior physics major Ronald Alexander will be attending the Massachusetts Institute of Technology Summer Research Program (MSRP). MSRP is a nine-week

program from June 10- August 11. Alexander will be expected to publish an article on his research work at the end of his internship.

Desmond Fernandez, a junior, received a summer research fellowship at the Mayo Clinic in Rochester, Minn. The fellowship is from the American Association of Physicists in Medicine from May 21- July 27. Fernandez will work under Dr. Chris Beltran, a radiation oncologist.

"These excellent students will also make a significant contribution in the creation of new knowledge through their research," said Dr. Diola Bagayoko, professor of physics and department chair. "They have already made discoveries in previous summer internships."

Alexander and Fernandez will receive a stipend with their summer fellowship.

1st Regional Science and Engineering Conference Presented by NextGenC3

The NextGenC3 Composite C.R.E.S.T Center hosted its first Regional Science and Engineering Conference April 4-5. Undergraduate and graduate students were given the opportunity to network with peers and faculty in their field during the conference.

The conference held in the PBS Pinchback Hall brought students on all levels together. "They were able to network and present their research to a multidisciplinary audience of their peers," said Fareed Dawan, assistant director of NextGenC3 and administrator of the conference.

Ledet is also the winner of the Educational Testing Service Presidential Scholarship for HBCU students for the academic year 2011-2012.

Clinical Ed Students Efforts Reverse Convictions in Louisiana Supreme Court Client Gets New Trial

During Fall Semester 2011, students in Prof. Donald North's Criminal Law Clinic got the opportunity of a lifetime when the Louisiana Supreme Court appointed the clinic to represent Glen Dale Nelson.

Nelson had been convicted on four counts of armed robbery, conspiracy to commit armed robbery, and a weapons violation after a jury trial in Ouachita Parish. The Second Circuit affirmed the conviction, but the Louisiana Supreme Court granted a writ application and appointed the clinic to brief and orally argue the case.

All of the students in the class contributed to the research and building the oral arguments, but four students – Sawyer Halbrook, Amber Owens, Sarah Margaret Smith and Scott Stansbury – took the lead. Halbrook and Smith assumed primary responsibility for the writing the 28-page brief, and Owens and Stansbury argued the case before the Supreme Court in New Orleans. On the day of the argument, the students met Nelson's mother and fiancee', who sat in the back of the courtroom praying and holding hands during the argument. Owens said that it "was at that moment I realized a man's life was in my hands."

On March 13, the students learned that their hard work paid off. The Supreme Court reversed Nelson's convictions, vacated his substantial sentences, and remanded the case for a new trial. All four of the students credit the clinic with giving them invaluable experience that puts them steps ahead of the game when they start their legal careers.

The SU Ag Center recently signed a Memorandum of Understanding (MOU) with St. Landry Parish Government on a garden project that will enhance the quality of life of the community while saving the government some money. The MOU proposes a garden project for St. Landry Parish in which the parish government will provide land for the garden in Opelousas near the local airport. Southern University Ag Center will provide technical assistance and training for inmates and field workers.

The garden will be run by inmates from the parish prison under the supervision and management of parish personnel.

In the first year, the one-acre garden will grow sweet corn and vegetable crops with the potential of expanding to four acres in coming years. The training will include workshops and handson experience in the gardening operation, from raising seedlings, transplanting, maintaining to harvesting.

Initially, the seedlings will be raised at the Southern University Agricultural Center green house. In the future, a garden storage shed will be erected onsite to enable the garden to raise its own seedlings. The produce will feed the inmates and the surplus will be sold to the community,

thus increasing access to healthy food in St. Landry community, saving the parish some money and generating income.

The purpose and scope of the project as delineated on the MOU are: to develop a garden that will be run by inmates so that they will have fresh supply of healthy food to eat and to share; to train inmates with valuable gardening skills that will help them with job opportunities upon their release; and to use the garden for model demonstration for communities and students in St. Landry Parish.

Hibiscus, known for its medicinal effects in lowering high blood pressure, is also yielding other products of economic impact as local restaurants take it to another level by using its jelly in dishes such as stuffed pork loin made with cherries, charizo and hibiscus jelly. The *G Spot* restaurant owner, Chef Guidry, recently posted on his blog how he incorporates the jelly into his stuffed pork loin dish.

"Well, my dad gave me a jar of hibiscus jelly that the (Southern University) Ag Center gave to him. I had never tasted anything made with Roselle, so I was really anxious to try it. It has a very unique taste — a light, peppery, licorice flavor. I recently used it to prepare this SERIOUS stuffed pork loin ... Delicious!"

Chef Guidry also made a statement that is very powerful and much appreciated by the Southern University Ag Center:

"One of the cool things that scientists at the S.U. Agricultural Center are doing is developing and finding uses for *Hibiscus sabdariffa*, the *Roselle* species of the hibiscus

plant. They are investigating its nutritional value under various growing conditions, and plan to introduce its products to food markets and to reach our small farmers to increase its marketability."



SECOND CHANCE 2 RECOVER IN BOSSIER PARISH

Two financial planning workshops were held at the Caddo Correctional Center on February 2 and 13, by Katherine Ervin, parent educator, Bossier Parish. There were 140 inmates in attendance for both workshops. The purpose of classes was to prepare inmates for release by enhancing their understanding, knowledge, and skills that will enable them to assume economic roles and make financial decisions with confidence and competence.

Through these classes, the inmates became aware that many families have similar problems when there is "too much month and not enough money." They learned that the first step toward being successful is identifying what they want out of life.

The inmates understand that some of the major expenses they have to face in life include education, transportation, housing, raising children and healthcare. Therefore, to be financially successful, they must learn as much as possible about their financial situation in order to reach their goals.

They learned that managing their finance is a decision, a determination, a mindset and focus that must remain throughout their life time.

In the classes, the inmates also learned that they need to "earn it, manage it, oversee it, and take care of it" like a "Rock Star." Ms. Ervin shared with the inmates that it's not what you make, but what you save versus what you spend that determines your wealth. She emphasized the importance of knowing how much income to expect over a period of time and to budget accordingly.

"My goal as an educator is help inmates develop financial planning skills and learn how to budget because it is an important part of money management," said Ervin.

Congratulations to our Honda Campus All-Star Challenge Team. During the finals (The Great Eight) held April 2 in Los Angeles, our team competed extremely well, but unsuccessfully against Morgan State University, 490 – 460.



During the opening rounds of the competition, SUNO defeated the following teams in the Round Robin series: Round 1 – Hampton University – scores 440 -390; Round 2 – Chicago State University – scores 670 – 155; Round 3 – Elizabeth City State University – scores 645 -255; Round 4 - Tuskegee University – scores 540 – 365; and Round 5 – Claflin University – scores 400 – 385. Our team advanced to the semi-finals where they defeated Fisk University, 515 – 475.

Honda Campus All-Star Challenge (HCASC) is a Q&A game that combines academic material, popular culture and sports in a format emphasizing quick recall. African American history and culture are prominently featured in the questions. The HCASC season involves two levels of play—Campus Games and the National Championship.

SUNO's team consists of Benjamin Franklin High School graduates Terri Simon Coleman, Andre Davis, whose also a member of SUNO's men's basketball team, and Dalvin Ford, Jr. Other members include former two-time Delgado Community College SGA president and Abramson High School graduate Marc Guichard, Catheryn Major, who graduated salutatorian of Warren Easton High School in 2008, and Tiffany Campbell. Guichard says that being selected for the team validates his family, himself, and the child psychologist who said that he was beyond brilliant at the age of four. "From graduating kindergarten in five months to failing seventh grade and barely graduating high school, and then ascending to the highest seat that a Louisiana college student can achieve, I've experienced a lot," he said. "Being on the team has allowed me to totally be myself."

During a pre-National Championship Tournament event held earlier this year at Prairie View A&M University, Tom Cunningham, an official with the national tournament, informed the audience that SUNO's team set a precedent by correctly responding to ten questions in one minute, with 29 seconds to spare, during the Ultimate Challenge Round.

"I am often awestruck by these gifted young people, their scholarly banter and high-level discourse," said Ruth W. Johnson, director of SUNO's Educational Talent Search Program (ETSP) and campus coordinator of the University's Honda Challengers since 2006. "SUNO is a Mecca of academic opportunities, where unconventional yet gifted students converge to hone their skills as well as themselves. This activity addresses the intellectual need for students to pit witagainst-wit in friendly, but serious competition."

Coaches include Amelia B. Sellers, data manager for SUNO's ETSP, and former SUNO SGA president and Honda team captain Eugenie Tobin. Since 1997, SUNO's Honda Challengers have participated in ten National Honda Campus All-Star Challenges, winning more than \$32,000 in grants.

"On the Honda Team, I've made lasting friendships and financed my education. I found a fun activity that I can be proud of and put on my resume," said Ford.
