# D. APPROVAL TO DELEGATE AUTHORITY TO THE SOUTHERN UNIVERSITY SYSTEM PRESIDENT TO APPROVE A PLAN TO IMPROVE PUBLIC HIGHER EDUCATION IN COMPLIANCE WITH LEGISLATIVE ACT 419

#### -System Report

President Mason provided an update on the following:

- Grants received by the University in support of the National Demonstration Project on Black Men
- Work underway to implement the Honore' Center which has been appropriated \$500,000 by the Louisiana Legislature include the employing of staff, identification of faculty; and preparations for the first class in June 2012.
- The partnership between SUSLA/SUNO which will allow SUSLA to offer developmental courses on SUNO's campus and on-line.
- Progress to date on implementation of on-line classes on the three campuses, through a partnership with E O Serve Corporation.
- O Increase in membership in The 1880 Society, headed by Dr. Darnell Peterson and Mr. Collis Temple, which seeks persons to make an immediate contribution to Southern University in the amount of \$1,000 and pledge \$5,000 over the next five years. The Society's goal is to recruit 1,000 members; however, only the first 30 who make the required pledge will be considered to be charter members.

#### **SUBR**

The jersey of former SUBR basketball star, Bob Love, will be retired in a special ceremony during the SU v. GSU basketball game on Saturday, January 7, 2012. Board members were invited.

#### **SUNO**

U.S. Senator Mary Landrieu has successfully amended legislation to allow SUNO, Xavier and Tougaloo to have their loans forgiven by the US Government. SUNO's loan amount is \$44 million.

#### **SULC**

Professor John Pierre announced that pre-Law Day, the Law Center's recruitment effort, will be held on February 3, 2012.

Prof. Pierre also advised the Board concerning on a federal case involving Historically Black Colleges and Universities (HBCUs) in the State of Maryland. Four HBCUs are being represented by the Coalition for Equity and Excellence in Maryland Higher Education which is seeking legal redress in the amount of \$2 billion against the Maryland Higher Education Commission. The plaintiffs argue that the Sate continues to maintain vestiges of dual and unequal systems of higher education between the HBCUs and Traditional White Institutions (TWIs).

Professor Pierre was asked to keep the Board abreast of this case and advise of the impact, if any, on for HBCUs in Louisiana.

#### **SUSLA**

Note was taken that Chancellor Belton's absence at today's meetings was the result of there being no agenda items for his campus.

#### -Higher Education Commission Report

Mr. Patrick Bell reported the final recommendations from the Commission which was mandated by HCR 184 to study and submit a plan for reorganization relative to the governance of higher education in Louisiana. The report is scheduled to be sent to the Legislature on January 12, 2012.

#### SIGNIFICANT ACCOMPLISHMENTS/ACHIEVEMENTS

#### **SUBP** Chancellor Visits Turkey

The Chancellor returned on January 21, 2012 from a seven-day trip to Turkey where he visited seven cities. Accompanying the Chancellor on this trip was Professor Osman Kandara of the Department of Computer Science. During the trip, they met with officials from eight universities, one private high school, one private research center and two other educational agencies.

Memoranda of Understanding (MOUs) were signed with four universities. SUBR also agreed to study and consider the possibility of a 3+1 or 2+2 program with Marmara University for a dual degree in Computer Science and Computer Engineering. Dialogue on course articulation for such a program was initiated during the visit. The MOUs will facilitate the implementation of sponsored visiting scholar programs with SUBR and other possible cooperative ventures.

Invitations were extended to representatives from all of the universities and the high school to visit SUBR. Invitations were also extended to the Congressman with whom the SUBR Team interacted and with higher education council members.

The team also met with eleven individuals who were considered friends or who were past graduate students or visiting scholars at SUBR.

The principal of the private high school visited by the team offered to assist SUBR by administering the ACT or SAT to prospective students, if such assistance were appropriate and possible. The Chancellor's visit has essentially opened the lines of communication with secondary and postsecondary institutions in Turkey. SUBR will now seek to build mutually beneficial relationships with these institutions.

#### SUBR's Baseball Team to Participate in Major League Baseball — Sponsored Event

Once again, Southern University's Varsity Baseball Team will participate in the annual round-robin baseball tournament designed to give Historically Black Colleges and Universities and their baseball teams national exposure. This is the fifth such tournament sponsored by Major League Baseball (MLB). The event will take place February 17-19, 2012 in Houston, Texas. A total of five teams will represent HBCUs in this tournament – Southern University, Grambling State University, Alabama State, Prairie View A&M and Texas Southern University.

"As one of the first teams to be a part of previous MLB Urban Invitational Tournaments (held in Compton, California), we are excited to once again collaborate with MLB to try to make this event bigger and better," Southern's Coach Roger Cador said, as quoted in a January 19, 2012 article in <u>The Advocate</u>.

# Professor Diack addresses international conference in Paris

Professor Moustapha Diack, in the Department of Science/Math Education, was a guest speaker at the recent International Conference on Digital Innovations and Development held in Paris at the National Library of France.

The event was conjointly organized by the Network Society of the Great Enterprises of France, the Information Technology Services Management Forum of France and Cio Mag company. Professor Diack's keynote presentation, "Next Generation eLearning Solutions: Challenges and Opportunities," focused on the emerging eLearning technologies and evolving international standards for deploying the solutions.



#### Department of Mass Communications Received Committee for Reaffirmation Visit

On Sunday, January 22, 2012, the visiting team that conducted a site visit for the reaffirmation of accreditation for the University's Mass Communications Program arrived on campus to officially begin its review and deliberations. Every aspect of

the program was reviewed by the team. There were five Mass Communications experts on the team. Present at the opening luncheon were members of the Mass Communications faculty, members of other academic departments in the College of Arts and Humanities, members of the administration and members of the department's advisory board

The team invited the luncheon attendees to participate in a discussion on how the faculty and students of the department interacted with other campus units and with external agencies. The team then proceeded to engage in the next activity as outlines in its itinerary. The visit was from January 22-25, 2012. Recommendation(s) from the visiting team will be submitted to the Accrediting Council on Education in Journalism and Mass Communication for action during the month of March.

#### Norflet Progress Fund Awards \$750,000 to SUBD for Path to Financial Independence (PTFI) Project

The Path To Financial Independence (PTFI) Project, led by Southern University, is a collaboration among Historically black Colleges and Universities (HBCUs), Predominantly Black Institutions (PBIs0 and Hispanic Serving Institutions (HSIs). The purpose of this project is to assist low and moderate income individuals and families with access to free income tax preparation services, as well as financial education and financial literary services, that will help those individuals and families implement asset and wealth building strategies. This project was awarded \$750,000 by the Norflet Progress Fund. The Principal Investigator is Dr. Alma Thornton, Director of the SU Center for Social Research.

#### "Small Business Education SU Holds Kickoff\*\*

Southern University's Louisiana Small Business Development Center held a "Small Business Education Series Kickoff" at 8 a.m., Saturday, Jan. 28 in the Global Conference Center, room 313 of T.T. Allain Hall.

The workshop was free and open to the public, but advanced registration was required due to limited seating.



Southern University students and mentors were among a number of universities that spent 10 weeks at the U.S. Department of Energy's Advanced Photon Source and other facilities and divisions at Argonne National Laboratory as part of the DOE/National Science Foundation-funded Faculty and Student Teams (FaST) program.

The program provides hands-on research opportunities for faculty and students from colleges and universities with limited research facilities and those institutions serving populations underrepresented in the fields of science, engineering, and technology.

SU civil engineering students Steven Robins, Jasmin Richardson, Courtney Gordon and their mentor Riyadh Al-Raoush studied at the GeoSoilEnviroCARS x-ray beamline at the APS. Under the guidance of Mark Rivers (University of Chicago and GSECARS), the group performed microtomography experiments on fluid saturated soil columns, important for understanding environmental remediation efforts.

They did a complete experiment from start-to-finish, including designing a real-time flow apparatus with SolidWorks three-dimensional computer-aided design software, helping to build it, and treating the soil columns in the laboratory. They then spent four 24-hour days in a row collecting the data at the microtomography facility at the GSECARS station 13-BM-D, and analyzed the more than 100 gigabytes of data they collected.

Gordon and Richardson are seniors and Robins is a junior. Robins and Richardson are Baton Rouge natives and graduated from Scotlandville High School. Gordon is a native of Greensburg, La., and a graduate of St. Helena Central High School.

Argonne conducts leading-edge basic and applied scientific research in virtually every scientific discipline. Argonne researchers work closely with researchers from hundreds of companies, universities, and federal, state and municipal agencies.

#### **SUNO Anticipates Enrollment Growth**

# January 2012



SUNO anticipates 9% enrollment growth, 99% return of pre-Katrina student population for Spring 2012. Preliminary figures for the Spring 2012 semester indicate that enrollment at Southern University at New Orleans (SUNO) will reach 3,597, a 9% increase from Spring 2011. The Spring 2012 enrollment figure represents a 99% return of SUNO's pre-Katrina student population of 3,647. The official enrollment numbers will be confirmed on February 3rd, after students' final tuition payments have been made with the University.

"We attribute this continuing success to the fact that more students are making SUNO their first choice to pursue higher education, and the hard work and dedication of our nurturing faculty and staff," said Victor Ukpolo, Ph.D., SUNO's chancellor. "Our approach of aggressively working in collaboration with a host of high schools is paying off, as increasingly more students are getting better prepared and working harder to meet the new expectations of our higher admissions standards."

College of Business & Public Administration: Dr. Igwe Udeh, Dean Report on Major College of Business Activities:

Accreditation Progress Report:

The CBA Dean, Dr. Igwe E. Udeh and the CBA Coordinator of Accreditation Services. Dr. Frank Martin, have been compiling the Self Evaluation Report (SER) based on information and input from the four faculty-led AACSB accreditation subcommittees - MFFA (Missions, Facilities, Finance & Administration Committee); SARPD (Student Admission, Retention & Professional Development Committee); ITTM (Instructional Time & Talent Management Committee); and LGCA (Learning Goals, Curriculum, & Assessment Committee). The SER is due in April 2012, and a campus visit is expected by October 2012. Drs. Udeh and Martin were on campus throughout the 2011 Christmas holiday to collect, classify, and analyze data provided by the CBA faculty concerning their achievements in research, teaching, and service over a five-year period.

The MFFA steering committee has developed the initial outline of the 2012-2017 Strategic Action Plan which will be presented to the full MFFA Subcommittee for review and expansion. An initial review indicates that the college met all of its strategic goals for the 2006-2011 Strategic Planning period.

The ITTM and the MFFA subcommittees have collaborated in collecting faculty vitas prepared according to a specified template to ensure consistency of information and ease of use by reviewers.

The SARPD subcommittee has provided detailed demographic data on CBA undergraduate and graduate students that should be helpful in preparing the SER reports. Effort is under way to assess the Fall 2011 performance of various student demographic groups.

The LGCA subcommittee has adopted a uniform syllabus template which was distributed to faculty for implementation. The review of Assurance of Learning data provided by faculty is in progress. The four Learning Goals adopted by the college are communication, analysis, technology, and ethics. Additionally, each degree program (ENTR, MGIS-U, MGIS-G, and PADM) is in the process of developing subdimensions and rubrics for assessing individual degree program learning goals.

CBA Building Electrical and data wiring for the Stock Market Trading lab as well as electrical and data wiring for the Tutorial Lab and Student Mentoring Center began on Thursday, January 25, 2011. Additional new furniture and equipment were delivered to the building. Interior and external finishing touches are ongoing at the building as of January 24, 2012. The contract for the Building was awarded to Stallings Construction Co (Mike Stallings, President) on February 4, 2010, at a cost of \$3,365,400. Ground was broken on March 24, 2010. Pradere Office Products of New Orleans, LA was selected to provide furniture for the new CBA building. The

contract was awarded on Tuesday, June 21, 2011. Pradere has already taken steps to ensure that the furniture is delivered on a timely manner.

On August 19, 2011, Drinkable Air published its First Quarter Report featuring the performance evaluation of Chameleon 60 Atmospheric Water Generator conducted by researchers at the Southern University Research and Extension Center.

Upon request from Drinkable Air Technologies for equipment evaluation, the Southern University Ag Center conducted a pertest from formance June to August 2011. The major goal of the company is to improve our environment with new technologies at affordable prices. Hence, the company designed and developed the Atmospheric water generator (AWG) Chameleon 60 that generates water from the humidity in the air, condenses, processes and purifies it into clean drinkable water. This environmentally friendly method of water supply has great potential to serve as an alternative method of water supply for humans as well as animals and plants,

provided it is cost-

effective compared with other sources of water generators.

The system eliminates bacteria and purifies the water with an ozone process, which oxygenates the water. The potential will have high international demand particularly in developing countries with scarce drinkable water supply and during humanitarian relief situations.

This study is limited to quality and quantity of water production and does not include mechanical and electrical issues that affect the equipment's reliability.

The objective of the study was to perform equipment performance test on the equipment with respect to quantity and quality of water produced and electric usage in terms of KWH consumed.

Performance test of Chameleon 60, AWG was carried out in Baton Rouge at the Southern University Ag Center campus. The unit was delivered by Drinkable Air Technologies (DAT) to Southern University Agricultural Research and Extension Center (SUAREC) on June 6, 2011.

The equipment was placed on level concrete blocks and was connected to 220 volts electrical box and meter to measure the electric usage (KWH) for water production. Volume of water produced and KWH consumed were measured at different intervals (5 min, one hour,12 hours and 24 hours). Daily hourly temperature and relative humidity were obtained from the Southern University weather station located approximately 300 ft away from the equipment. Water was collected in a graduated cylinder and 5 gal containers. water quality For analysis, filtered and unfiltered water samples were collected and analyzed at the Calli-Environmental gary Center.

#### Drinkable Air

The summary results of the water quality analysis obtained from the Calligary Environmental Center focused on the performance evaluation of the Atmospheric Water Generator, Chameleon 60. The machine was rigorously tested and evaluated based on its water production capacity and electrical usage. Several additional improvements were made to the equipment during the course of the test. For the period between June and August 2011, the AWG, Chameleon 60 had the capacity to produce up to 77 gallon of water in 24 hours under Baton Rouge weather conditions.

Because of lower temperature and higher humidity at nighttime, the unit produced more water efficiently at night than daytime.

It was not possible to test the unit at lower humidity than 53%. Hence, it was recommended that the equipment be tested at lower humidity regions as well. Mathematical models that predict the water production as a function of humidity and temperature were developed. Water quality test results showed it was within the acceptable range levels. Since this way of atmospheric water harvesting has great potential for wide agricultural use, all research efforts will be made to explore other sources of energy besides electrical power to run the machine.

#### SMALL RUMINANT ACE MEETING HELD AT SU AG CENTER

The annual small ruminant Ag Center Exchange (ACE) group met on December 15, 2011 at Efferson Hall, on LSU campus. The purpose of the meeting was to review and discuss small ruminant research and extension activities and to identify critical program needs for the future.

Professor Sebhatu Gebrelul, Animal Science, Associate Professor Renita Marshall, Animal Science, Professor Yemane Ghebreiyessus, Urban Forestry, Lisa Gray, Research Associate, Eugene Runles, Farm Superintendent, and Linus Harleaux, Assistant Research Farm Superintendent, represented the Southern University Ag Center.

After a brief welcome and introductions by Dr. Jim Miller, Chair of the ACE group, Dr. Gebrelul reported the status of the "Sustainable forage management practices through intensive sequential grazing system for cattle and goat production" and discussed the goal, objectives and current activities.

Gebrelul also identified two pending projects; (1). A systematic study of novel food pathogens, safety practices of small farmers, small processors and emerging markets for small ruminants, AFRI/USDA and (2) Mitigation of greenhouse (GHG) emissions in southern integrated beef-pasture system, AFRI/USDA (Scaglia, G., LSU Ag Center, New Iberia) that the goat unit is collaborating in.

On behalf of Dr. F. Malekian, who was unable to attend the meeting due to other official engagement, Dr. Gebrelul also reported the goal, objectives and activities of the Capacity Building Grant entitled "Nutritional content, antioxidant activity and safety of valueadded goat meat products".

The Small Ruminant ACE agreed on the need for research to provide producers with information on improved practices to increase forage yields, species and varieties of clovers and stocking rates.

#### THE SU AG CENTER ENHANCES TRAINING OF FUTURE SCIENTISTS

The Southern University Ag Center has been sponsoring graduate research in urban forestry and agriculture for the past 10 years. Dr. Ferchaud's research yielded a dissertation entitled "Localization and identification of Flavonoids/ phenolics in selected southern tree species relative to Ultraviolet –B protection."

"The research done by Dr. Vanessa has contributed new knowledge that enables us to have a better understanding of UV-B tolerance mechanism in Southern trees. Such information is useful for tree selection and forest management in forestry and urban forestry, as we continue to face the uncertainty in global climate change patterns," said Dr. Qi.

Danzy's research produced a thesis entitled "The effects of coopercarbon core-shell nanoparticles on three blue-stain fungi."

"Ms. Michaela's research has opened a brand new face of using nanotechnology to combat forest diseases," Qi said

Dr. Qi also stated that the research has explored the feasibility and effectiveness of the coppercarbon core shell nanoparticles in controlling blue stain fungi that are the major diseases causing death in southern pine.

Qi reported that the research results look very promising in sustaining the Louisiana urban forest. The USDA-NIFA awarded the funding for both projects to SU Ag Center through Project Director Yadong Qi
