Dr. Broussard recently served as Athletic Director at Centenary College in Shreveport and prior to that served as Associate Athletic Director and Executive Director of the NSU Athletic Foundation at Northwestern State University. While at Northwestern State he was successful in increasing external giving to the Athletic Department and assumed additional responsibilities in athletic operations that provided him with a broad based experience. His credentials are attached.

I request your approval of this appointment and submission of the recommendation to the Board of Supervisors for approval. Dr. Broussard and I have tentatively agreed to contract terms should his appointment be approved.

Re: Letter of interest for Director of Athletics position at Southern University

February 23, 2012

With this letter, I wish to express my interest in the position of Director of Athletics at Southern University. My love for my home state of Louisiana and experiences as an All-American and National Football Foundation/College Football Hall of Fame inductee have motivated me to pursue a career in higher education, college athletics, and institutional advancement at Southern University, and uniquely suits me for success in this position. Critical times seek capable leadership in order to convert crises into opportunities, and I am determined to do so at your prestigious institution.

In my tenure at Centenary College as Director of Athletics, I helped steer the athletic department into its first full year as a member of NCAA Division III, navigating a tenuous media and public relations cycle, managing a fiscal crisis, overseeing resurgence in student enrollment, and enabling a discouraged, but determined staff to achieve considerable success. I attended college-sponsored functions and made myself accessible to the media (television and print, as well as through public and internal relations on campus) in order to share the new narrative of Centenary Athletics. Within my first 30 days, I submitted a budget that absorbed a 55% YOY cut in a manner that appeased the administration and encouraged coaches and staff that success was attainable, as well as a balanced budget proposal through 2014-15. By the end of my second month, I'd successfully submitted an appeal to the NCAA's decision to place Centenary under probationary review, avoiding the derailment of the transition into Division III. In nine months, I oversaw a department that earned conference championships, broke records, and had winning records in sports that had not earned them in many years. I will bring this same commitment to engagement, fiscal responsibility, and excellence to Southern University.

My managerial experiences at NSU (external relations staff and three areas for sport oversight) and Centenary (oversight for all athletic operations) have given me great leadership opportunities. However, I have also been involved in institutional work on behalf of athletics in which I was not the lead. In the past twelve months, I have assisted two athletic departments with their NCAA institutional self-studies. I assisted with the submission of Centenary College's year one submission to the NCAA for Division III reclassification and oversaw its progress in year two. In my final year at NSU, I assisted with the Diversity, Gender and Inclusion areas of the self-study, drafting responses and regularly meeting with the assigned team members to ensure a successful submission. During these experiences, I gained valuable knowledge about and developed my commitment to student-athlete welfare, equity, APR performance, and institutional compliance.

With regard to representing the athletic department externally, I have also excelled. Though I was not permitted to raise private funds for athletics at Centenary College, I have more than five years of experience in institutional advancement and fundraising, and a career attainment of over \$8 million. Most of my experience came as Associate Director of Athletics of External Relations at Northwestern State University. In my 4+ years as director, I helped set or establish over 40 annual or categorical records, including total attainment, annual fund attainment, membership, corporate sales, gifts-in-kind, endowment attainment, and planned giving. The growth of annual total attainment for the NSU Athletic Association increased over 120% from 2006-07 to 2010-11.

During my tenure at NSU, my staff and I focused on creating a culture of not only asking for support, but demonstrating the need, value, and pride donors can feel in giving through a comprehensive public

relations campaign. We regularly recognized donors who made large gifts, at sporting events, in profiles on our website and literature, and we began introducing riders which leveraged multi-year commitments higher, and targeted donors whom be believed to be underperforming with larger asks. I routinely analyzed trends in donor giving, providing weekly reports through the first half of the year and then monthly as the year closed. I work excellently with others, am as interested in mentorship as I am in mentoring, and have extensive experience working with campus committees, with faculty and staff, with community organizations, and with volunteer staffs.

I am committed to making face-to-face donor appointments and vigorously supporting alumni relations. I regularly conducted three face to face appointments on a weekly basis with donors and prospects within a one-hour radius, and supplemented these visits with regular trips to Houston, New Orleans, Dallas, Austin, Lafayette, and other areas within a four-hour radius, which were in conjunction with Alumni or Admissions-sponsored events. I would conduct multiple daily appointments in these areas and then represent the university at the sponsored events. I am committed to assisting Southern University in identifying and attracting more private and corporate support by working with Alumni Federation and SUSF staff, spending time on the road visiting donors and attending sponsored events, and sharing the skill and motivating coaches and staff to engage in this process, as well.

I also have experience in securing major gifts in excess of \$100,000. The largest cash gift I was a lead in securing was in excess of \$200k, and was a single donor funding of a pavilion facility. I also developed mini-campaigns, identified and solicited prospects, and secured gifts in excess of \$100k for facility enhancements. The planned giving program I introduced (The Second Century Circle) was featured by the National Association for Athletic Development Directors, and secured three gifts in its first year, including the largest, single private donor bequest in the 126-year history of NSU University, a \$1.07 million estate gift. Additionally, my working knowledge of charitable trusts, annuities, bequests, and estate gifts was sufficient to compel deferred gift-giving, bringing in \$1.61 million in planned gifts and an additional \$100k pledge. I also coordinated the NSU Athletics annual fund for 5 years. This included design of the mailout, development of the annual cultivation/solicitation/stewardship calendar, and coordination of premium seating/benefits, database management, and donor recognition events. My first year coordinating the annual fund was its first year over \$200k in cash gifts, and each year it exceeded this mark comfortably.

I have prepared and managed deliverables on corporate, foundation, and government grant proposals. I assisted in the collection of data to prepare and fulfill the promise of two large multi-year grants, a \$400k grant from the Office of Culture, Tourism, and Recreation (under Lt. Governor Mitch Landrieu) and \$300k Boyer Project grant for the study of disruption in the classroom at the University of Arizona. I worked with individuals in local government, on-campus, and presented at national conferences to fulfill requirements of those grants. Individually, I composed and was awarded eight grants from university foundations and corporations totaling \$23,300. I conducted ten fundraiser/special events at NSU and volunteered for eight more. The two largest events I conducted were the 2007 and 2009 Scholarship Auctions. For each event, I coordinated volunteer staffs of 25 or more, secured \$100's of thousands in items to be auctioned off in live and silent auctions and netted \$93,000 in two events. The golf tournament fundraisers I coordinated secured approximately \$37,000, and generally hosted anywhere from 30-100 golfers. I will bring these abilities to bear for Southern University Athletics, ensuring that private, corporate, and community supporters have opportunities to interact with and show support.

I am a university-trained rhetorician, experienced public speaker, and a published scholar with an excellent reputation among athletic administrators. I have presented at local, regional, and national conferences, hundreds of panel discussions, and am in my 12th year of teaching at the college level, which gives me a unique rapport with students, faculty, and administrators. I have run board meetings, managed a staff as large as 34 employees, and communicated messaging to a donor base through social media, email newsletters, and campaigns. I communicate professionally, efficiently, and courteously, am proficient in Microsoft Office Suite and adept at managing donor databases. I am versatile, adaptable, as willing to teach as I am to learn, and am well-prepared for the challenges of being a 21st century Division I athletic director, and to promote student-athlete excellence in all phases.

Thank you very much for your consideration, and I await your response eagerly, and am also submitting a full curriculum vita, detailed gift record, and references for your perusal.
