SOUTHERN UNIVERSITY BOARD OF SUPERVISORS

Off Premise Property Loan Policy

The Southern University Board of Supervisors (Board) recognizes that a need exists for the members of the Board and its employees to utilize property off premises for position/job related purposes or for furthering the Board's mission.

This policy has been established to govern the use of off premise property in the care of the Board:

1. General Use of Board property off premises shall be limited as follows:

A. **Outside entities.** The loan or off premise use of Board property to or by anyone other than members and staff of the Board, is prohibited unless authorized through an agreement between the Board and another public agency for the mutual benefit of both parties.

B. **Students.** The loan or off premise use of Board property to or by a student is prohibited, unless a responsible college official has determined that such use is necessary for instructional purposes.

C. **Governing Board Members and Employees.** The loan of Board property to or by a Board Member or staff for personal reasons is prohibited.

2. Responsibility for property taken off the University's premises:

A. While the property is off premises, it is in the care, custody, and control of the lendee. The lendee is responsible for the property and its appropriate use and maintenance until the equipment has been returned with a receipt duly signed by the Board's office. The lendee using the property must take all measures necessary to ensure the security of the property.

B. While the property is in the possession of a lendee, he/she is responsible for returning the property to Office of the Board of Supervisors in the same condition as lendee received it. Lendee agrees to assume the risk of loss or property damage due to the lendee's failure to exercise due care in the possession or use of the property. The phrase 'due care' means that level of care appropriate under the circumstances.

C. Failure to exercise due care will be presumed unless the lendee can demonstrate that the property was lost, stolen, or damaged despite the lendee's exercise of due care. If the property is damaged as a result of a failure to exercise due care, lendee must agree to pay the cost of repair. The cost of repair shall not to exceed the original purchase value. The lendee assumes financial responsibility for loss or damage to property through their homeowner's insurance or personal funds.

3. Off premise loans of property to Board Members must be returned, prior to the end of his/her term on the Board and to Board employees prior to the end of their employment with the Board. All off

Premise loans of property, regardless of duration, will be monitored and inventoried annually by the Board's Executive Assistant or his/her designee and documentation on file in the University's property department. Verification of property return by completion of return receipt on the property loan agreement will be the lendee's responsibility and must be verified by the Board's Executive Assistant or his/her designee.

4. Loan or off premise use of property: The Board of Supervisors property loaned or taken off the University premises regardless of duration must be recorded on a property loan agreement. (See attachment). This form is used both to authorize and record the off premises use of Board property. The following information is required:

A. Identification of the lendee to be using the property off premises

B. Off premises location of property

C. Justification for taking the property off premises

D. Complete description of the item(s) to be taken off premises

E. Description of the condition of the property at date of loan

F. Signature of lendee agreeing to comply with the terms of the policy.



As executive director, Dr. Wilson partners the White House, 32 federal agencies, private and philanthropic entities to work to assist 105 HBCUs across the country.




Dr. Wilson received his bachelor's degree

Prior to working with the White House Initiative on HBCUs, he was an associate professor of higher education in the graduate school of education at George Washington University. He also served as the executive dean of GWU's Virginia Campus and helped to develop a strategic plan for the university.

The speaker challenged the graduates to prepare themselves to compete from a global perspective in a world that is becoming smaller and smaller.

<u>Renowned Author Awarded Honorary Doctor of Humane</u> Letters



Ernest Gaines, world renowned author, was recently awarded the Honorary Doctor of Humane Letters by Southern University and A&M College at Baton Rouge. Over a span of several decades, this Louisiana native has distinguished himself as a literacy giant of international acclaim.

He is the recipient of numerous awards, including the National Book Critics Circle Award for Fiction, the National Humanities Medal of the United States and the MacArthur Foundation

"Genius" Award. Mr. Gaines has also received prestigious grants from the National Endowment for the Arts, the Solomon Guggenheim Foundation and the Rockefeller Foundation.

Through his works, he has depicted the complexity of the African American experience and the human condition. He has been and continues to be a great source of pride for the State of Louisiana and a source of inspiration for aspiring young writers.

On Thursday, May 17, 2012, SUBR held a reception in Mr. Gaines' honor and on Friday, May 18, 2012, the Honorary Doctor of Humane Letters was conferred upon him during the 2012 Spring Commencement Exercises.

The program's primary goal is to use interdisciplinary research in the food and agricultural sciences to enhance participants' critical-thinking, analytical, writing, and oral communication skills. The Ag STARS Program is funded by a grant under the U.S. Department of Agriculture's Capacity Building Grant Program.

Dr. Patricia E. McLean-Meyinsse is the principal investigator for the grant; she was also the faculty advisor for the students' research papers.

SU AG CENTER CLIMATE CHANGE SYMPOSIUM DRAWS INTERNATIONAL PRESENTERS

The Southern University Agricultural Research and Extension Center hosted a symposium on climate change and ecosystem, April 24 at A. O. Williams Hall, attracting presenters from the United States and China. The goal of the symposium was to share research and educational information on how the change in climate and ecosystem is affecting the forests, wetlands and water, and ways to mitigate them to ensure sustainability.

The SU Ag Center Chancellor Leodrey Williams; Vice Chancellor for Research Adell Brown, Jr.; Vice Chancellor for Extension Gina E. Eubanks; and Vice Chancellor for Research and Strategic Initiatives at SUBR, Michael Stubblefield brought greetings to symposium participants.

During his welcome address, Chancellor Williams emphasized the relevance of the symposium to the current climatic changes that continue to have negative impacts on the United States and the world at large. Among the presenters were students, faculty and professionals from organizations such as Southern University; Louisiana State University; Columbia University; USDA Forest Service; U.S. Geological Survey; East Carolina University; University of Southern Mississippi; and Northeast Institute of Geography and Agroecology Institute, Chinese Academy of Sciences, Changchun, P.R. China.

Discussions included topics such as, An overview of trends, projections and potential ecosystem impacts in the Southeastern United States; An ecosystem approach to climate change and urban forestry education and research; What we know and how we know it; The role of the US Forest Service in climate change science and management; and Modeling and assessing the impact of climate change on the Amite River Ecosystem, among others.

SU Ag Center KICKs BUTTS at SHREVEPORT HEALTH FAIR

The Communities of Color Network, Regional Coordinator for Region VII, Urina F. Holt, hosted a Kick Butts Block Party/Health Fair to spread the word on National Kick Butts Day in Shreveport, March 22. The event was held on the corner of Texas Street and Louisiana Avenue next to SU Shreveport's Metro Center. Many community health vendors participated in spreading the word on the harmful effects of tobacco use.

The SU Shreveport cheerleading squad judged local middle and high school cheerleaders in a cheering competition. They made up chants and cheers on "No Tobacco" and "Stop Smoking." Contestants received trophies for "Most Spirit," "Most Creative Cheer" and "Most Motivated." Event participants had an opportunity to view the Institute of Tobacco, list of harmful ingredients found in tobacco, diseases caused by the use of tobacco, and the functions of a good lung compared to a lung that has had been exposed to tobacco smoke. Also available was the test that measures the age of participants' lungs by blowing into a tube.

Attendees had an opportunity to receive face-painting, write positive messages on sidewalk with chalks, play bingo, which listed ingredients found in tobacco and diseases caused by tobacco use. The crowd enjoyed hotdogs, chips, and drinks, and much more. The Communities of Color Network passed out t-shirts, rulers, back packs, pens, and kick butts stickers to event participants. Supporting vendors included SU Shreveport's Nursing Program, Dental Hygienist, Shreveport Police Department, and Fire Department, along with other local community health partners.

KTAL (Channel 6) came out and interviewed Ms. Holt on the importance of getting the message out to inform our youth on the use of tobacco. Holt spook on how tobacco was the leading cause of death among African Americans, and that some of the diseases caused by tobacco use include cardiovascular disease, heart disease, stroke, and cancer.

Holt brought awareness of the harmful effects that result from using tobacco to the participants. The Region VII Coordinator asked the participants to make a commitment that they would either stop smoking or for those who were not using tobacco, to never pick up the deadly habit of using tobacco, (spit tobacco or smoking tobacco).

The Communities of Color Network is an educational awareness program at the SU Ag Center, which addresses the unhealthy consequences of tobacco use and the dangers of secondhand smoke. The U.S. Centers for Disease Control and Prevention reports that Louisiana ranks second among the states with the largest percentage of African -American smokers at 27%, behind Michigan. The Coalition for Tobacco-Free Kids, (2009) reported that in Louisiana, approximately 690 adults die each year due to secondhand smoke exposure.


Eual Hall, Business Development Outreach Specialist, conducted a training session on "How to start a business."





Clark Building Demolition

APRIL 2012 The Clark Building is now being demolished after the long awaited removal of hazardous material from the building's interior. The first phase of trailer removal from the Lake Campus has begun. Sixteen (16) trailers are being deconstructed



and made ready for removal by the first week of May. The trailers that are being removed are: #16, #18, #27, #29, #30, #31, #32, #33, #34, #35, #36, #37, #38, #39, #40 and #41. The photographs featured on the next page are clear indicators of the work progression of the FEMA contractors and the University's contractors as the trailer removal project moves forward.

Phase II of the trailer relocation project is scheduled to begin the week of May 14, 2012, starting with the re-



moval of the following trailers: #10, #11, #12, #13, #14, #15, #17, #19, #25, #26, #28, #42, and #43. The removal process will take approximately four to six weeks for the FEMA contractors to completely remove all trailers in Phase II and repair the ground where the trailers once sat. Upon completion of the Phase II trailer removal, the area that once housed Phase I and Phase II of the trailers will be prepared to receive the new modular buildings.

Due to limited space, we will need to keep 14 of the existing trailers to house departments that were located in Phases I & II of the existing trailers. The trailers that will remain are in better condition that the trailers that are being removed. Once the modular buildings have been completed this fall, we will move the occupants from the trailers into the new buildings. Once the occupants have been moved into the new buildings we will remove Phase III of the trailers. Phase III of the trailer removal will consist of the following trailers: #1, #2, #3, #4, #5, #6, #7, #8, #9, #20, #21, #22, #23, #24, #44 and #45. As these trailers are removed, the land will be graded and repaired and made suitable for use by the University.





Collection by folk artist alvin batiste

The Southern University Museum of Art at Shreveport is featuring the work of Donaldsonville folk artist. Alvin Batiste from the Museum's permanent collection. The work will be on exhibit from January 25-May 18, 2012.

Alvin Batiste, folk artist, was born March 16, 1962 to James and Lillian Little Batiste in Donaldsonville, Louisiana. Nurtured and encouraged by his mother, he began drawing at the age of three. In 1991, he began to seriously consider art after seeing a demonstrative painting show on public television. Batiste recalls, "I [saw paintings by] Michelangelo and Picasso on television, and that's when I knew what I wanted to do." Batiste proceeded to go to Rossie's Custom Framing shop on Railroad Avenue to purchase brushes, paints and canvases. Thus, began the career of one of Louisiana's most prolific folk artists. Over the past four years, Batiste has had numerous exhibitions in Baton Rouge, Houma and Thibodaux, and has sold paintings to art collectors and museums throughout the country and Europe. His work has been featured in two new books, 20th Century American Folk, Self Taught and Outside Art and Contemporary American Folk Art.


Almost daily, you can find Batiste in the front window at Rossie's painting with his perpetual friendly smile. Rossie's has turned into a kind of gallery with rows and rows of Alvin's paintings along with other dime-store merchandise.

A folk artist is usually self-taught, often making art late in life, whose works are tied to personal history and experiences, and does not use the formal conventions of art. These formal conventions include perspective, light and shadows, etc. Alvin Batiste seems to be a phenomenal young man, who paints in a small store in Donaldsonville, Louisiana. With this god-given talent the artist manages to create beautiful works that exhibit a technical mastery that contradicts the fact, that he has no formal training in painting. Batiste uses both historical topics and humorous incidents from African American folk life as subject matter in his paintings.

Batiste, like some folk artists such as Sarah Albritton, writes narratives on the back of his paintings. Storytelling is an important part of African American folk culture. These stories that are passed down from generation to generation are embellished and enhanced for the listener. Batiste stories involve history, folk tales and antidotes. Scenes such as The Port Hudson Soldiers, Picking Pecans on Gay's Plantation, and The Baptism at the River convey Batiste's unique vision of the history of his people.

Professor Gail S. Stephenson, president of the Baton Rouge Bar Association, welcomed attendees at the opening ceremony of the Baton Rouge Bar Foundation Law Day, Friday, April 27, at the Baton Rouge River Center Theatre. Lt. Gen. Russell L. Honore was the keynote speaker on the theme honoring the Louisiana Bicentennial. Law Day video, essay, and poster contest winners received awards and a naturalization ceremony was held during the opening session.

Approximately 1,000 middle and high school students and their teachers attended the ceremony. They also attended mock trials held at the Baton Rouge City Court and the 19th Judicial District Court. Professors Stephenson and Regina James served as moderators for the courtroom sessions.

Professor Maurice Franks testified before the Louisiana House Committee on Criminal Justice and the Louisiana Senate in favor of a bill (S.B.303) to strengthen the right to keep and bear arms in Louisiana. The bill seeks to amend the Louisiana Constitution.

If approved by the House of Representatives, the constitutional amendment will be voted upon by the people in the November general election.

Rachel L. Emanuel, director of communications and development support, has been appointed by Justice Bernette Joshua Johnson to a three-year term as a board member of the Supreme Court of Louisiana Historical Society. The Society's purpose is to promote an interest in and understanding of the people and institutions which contributed to the development of Louisiana law.

Funeral Services Held for Former Law Student of the 1960 Baton Rouge Sit-In

Funeral mass was celebrated at 11 a.m. Friday, May 4, for former Southern University law school student John Burrell Garner, one of the participants in the 1960 Baton Rouge sit-ins, who passed Friday, April 20, in New Orleans. Services were held at St. Augustine Catholic Church, New Roads, Louisiana, with burial in the church cemetery.

Garner and university undergraduate Vernon Jordan of Baton Rouge sat in at Sitman's Drugstore on March 29, 1960. The two SU students and 14 others who participated in sit-ins at S. H. Kress Department Store and the Greyhound Bus Station, March 28-29, were arrested for "disturbing the peace." The students were tried and convicted in the 19th Judicial District

Court in Baton Rouge, represented by attorney Johnnie Jones, Sr., of Baton Rouge. Their cases were appealed by NAACP attorney Alexander Pierre Tureaud of New Orleans and resulted in the first sit-in case to be heard and decided by the U.S. Supreme Court.

The Court's 1961 ruling in Garner v. Louisiana, No. 26; Briscoe v. Louisiana, No. 27, and Hoston v. Louisiana, No. 28, overturned the students' convictions and contributed to the end of racial segregation at public facilities throughout the nation.

Former SU student leader Fred Prejean of Lafayette, Louisiana states, "Brother Burrell will be in my prayers and will be remembered as a man of courage and conviction. His spirit will continue to walk this earth and challenge all that threaten the God given freedom of man. Long live the spirit of the brave."

In 2004, Garner was awarded an honorary law degree by the Southern University Law Center along with the other former law students involved in the 1960 sit-ins, John W. Johnson, Judge Kenneth Lavon Johnson, and Donald Moss.
