There will also be mentoring and teacher professional development components.

Instructors from Southern's College of Education and Science and Mathematics Education Doctoral Program will be working with teachers, students, and parents, Young explained. "We intend to significantly impact the academic and social integration of WCHS students into a culture of college and career readiness."

White Castle students will also observe some class time and participate in activities at Southern's Baton Rouge campus, along with a performance by Southern's famous "Human Jukebox" marching band at White Castle High. "We are excited about the opportunity to increase student engagement and motivation to pursue college and careers," said White Castle High Principal Charley Handy, III.

The joint education effort is instituted in the name of Albertha Hasten, a beloved activist in her community, who died on Nov. 19, 2011. She served on the Iberville Parish School Board for 17 years, representing the White Castle area. Hasten also served as the president of the Louisiana Environmental Justice Community Organization Coalition. Llorens, Iberville Parish Superintendent of Schools Ed Cancienne, Iberville Parish School Board President Melvin Lodge signed the agreement Monday.

#### SUBD passes the GDAD Act



Louisiana's Board of Regents has announced that Southern University has passed the requirements of the GRAD Act. The GRAD Act is made up of several dozen benchmarks based predominantly on student success.

The Regents announced that all public colleges and universities were successful in meeting the required score for passage of the LA GRAD Act. "We are very proud of our institutions' performance this year under the GRAD Act," said Chairman W. Clinton Rasberry. "This shows that our systems are meeting the needs of our students and the communities which we serve."

Under the GRAD Act, which was approved by the Legislature in 2010, the Board of Regents (BoR) enters into six-year agreements which set institution specific targets, including annual performance measures that result in educational improvements by the end of the timeline.

BoR monitors the annual performance of each institution and submits a report to the legislature and the governor on the progress in meeting the performance objectives of the Act.

The GRAD Act includes four performance objectives—student success, articulation and transfer, workforce and economic development, and institutional efficiency and accountability.

Because each institution has its own targets for progress, it is measured against its own improvement plan during the annual review process. However, each campus MUST achieve successful attainment of the student success objective in order to retain its tuition authority and autonomy eligibility.

"Overall I am very pleased with the progress that our campuses have made with the GRAD Act," said Commissioner James E. Purcell. "We will continue working with our campuses in certain areas to provide guidance in identifying some specific strategies for growth."

#### **SUBD Summer Enrichment Drograms**

This summer, SUBR offered some sixteen summer enrichment programs on the Baton Rouge Campus. The 2013 Engineering Summer Institute (ESI) held its closing program on July 3, 2013. The ExxonMobil Bernard Harris Summer Science Camp has also held its closing program. This camp actually had Astronaut Bernard Harris to visit the camp and interact with camp participants! Several of the other summer enrichment programs have also ended their programs for the summer. Others are still in progress.

These summer enrichment programs provide a wonderful opportunity for student participants to develop in both academic and non-academic areas. The programs promote both intellectual and physical activities. Some of the programs emphasize the STEM disciplines, science, technology, engineering and mathematics. Other programs emphasize the arts and Humanities and physical education.


The students also have an excellent opportunity to observe life on a university campus. Having students to participate in these programs also provides an invaluable recruitment opportunity for Southern University.

The uniqueness of this online degree program lies in its various disciplinary concentrations, which allows Southern to accept prior credits and academic experience from prospective online degree students who wish to attain a degree at Southern in their chosen field of study.

SU System President, Dr. Ronald Mason, Jr., said, "The Bachelor of Arts in Interdisciplinary Studies online degree program is geared towards non-traditional and traditional students who are motivated to complete a degree with a unique experience that will complement their current occupation or prospects for advancement, and better prepare them for the future educational goals."

"Adding this program to our expanding inventory of online degrees allows students more flexibility for completion of their bachelor's degree. It's certainly aligned with our goal of branding Southern University as the online HBCU alternative," Mason said.

he Morehouse Black Farmers and Landowners Association. Incorporated, in collaboration Southern University and LSU Ag Centers, held the 12th Annual Field Day, July 19. 2013. It has grown into an annual event which occurs on the 4th Friday in July, starting at Mr. Armstrong's shop, and ending with lunch prepared by Mrs. Armstrong and others.

Farmers presently come from all parts of the South to attend the Field Day.

In attendance were farmers, landowners, organizing entities, personnel from USDA State Offices, and administrators from the SU and LSU Ag Centers.

This year, Representative Katrina R. Jackson, District 16, Monroe, member of the Agriculture, Forestry, Aquaculture and Rural Development Committee, was in attendance to show support.

The Morehouse Black Farmers have made a big impact on the local African American farmers by strengthening their relationships with USDA. agricultural companies such as FMC Corporation, Dupont. Terral Seed, Pioneer, and Syngenta Monsanto. Most importantly, through this event, farmers have built relationships with other African American farmers across the South.

Louisiana row crop farmers have challenges with marketing, droughts, floods, weeds, and labor. A major concern of the Morehouse Black Farmers is the continuation of row crop farmers in the next generation.

### Agricultural Leadership Institute Holds Productive Boot Camp

ession 5 of the Louisiana Small Farmer Agricultural Leadership Institute Boot Camp was held on Saturday, July 27th in Pride, LA. The theme for this session was: "Building a Sustainable Business: The Real Farm Experience." All the participants had the opportunity to visit two working farms in the area. The first farm was SnS Farm in Pride, LA. The SnS farm is unique in that it uses very little machinery and almost everything is done by hand. The owners, Shannon Simpson and his wife Rintha, (a member of the leadership boot camp), were very excited to share their knowledge with the group and offered a tour of the farm in spite of the bad weather. This farm sits on 15 acres and is home to goats, Zebu cows and chicks for egg production. The farm is truly an experiment in progress. The Simpsons use a quasi-intensive grazing system for their animals and plan to transition the cows to be used as oxen, and goats to be used as pack animals. They even bale their hay by hand, a practice that most of the other farmers were very interested in.

The second farm was the Robert Wallace, Jr. Family Farm, in the community of Chaneyville, on Port Hudson Pride Road, just outside of Zachary. This farm is a small cow / calf operation, which uses quality registered bulls to insure quality calves. Mr. Wallace has participated in various NRCS programs and made many improvements on his farm, which is currently being transitioned into a demonstration farm. Mr. Wallace is also a graduate of Class IV of the Small Farmer Agricultural Leadership Institute. Mr. Sam Willis, District Conservationist. USDA/NRCS, explained the conservation practices that are in place on the Wallace Farm and what other producers can do to enroll in the conservation programs.

Despite the inclement weather, the farmers in attendance were eager to learn all they could about this small family operated farm.

"I am shocked by the level of commitment and interest that all of the farmers have shown at this and all of the other sessions. They are really eager to see what other small farmers are doing and willing to share what works with their operations," said Dawn Mellion-Patin, PhD, Agricultural Specialist/project director.

A team of specialists generates research and extension information in a range of disciplines; particularly forage quality, dairy nutrition, wastewater treatment and nutrient management.

The tour continued to Mr. Warner Hall's garden where watermelons, green onions, red beans and many other healthy produce bloom. The next stop was Mr. Quincy Walker's Farm in Tangipahoa Parish. Youth and adults were permitted to harvest potatoes and squash to bring home. The group also visited Johnson Roping Pen in Amite, where Mr. Richard Johnson gave youth horseback rides and tour of the ranch.

The event consisted of nutrition information, tours of the LSU AgCenter Southeast Research Station in Franklinton, La., two home gardens, and horse ranch.

The SU Ag Center's E-Learning Center, a mobile unit in the Center for Rural and Small Business Development (CRSBD) made a presentation to event participants. Eual Hall, business development specialist, and LaKeeshia Giddens, e-Learning Director, discussed the procedures of how to start a small business. Individuals who visited the E-Learning Center received one-on-one counseling from the presenters. Package distributed included CRSBD and E-Learning Center brochures; the SBA Business Resource Magazine; information on the USDA's Rural Housing Loan and Grant Program; USDA Elderly Home Repair Program; registration forms and applications needed to legally operate a business; information on borrowing and lending; marketing information; and business cards for Hall and Giddens.

### SU Ag Center Launches Garden at New Light Missionary Baptist Church


outhern University Ag Center's extension associate for community garden, Stephanie Elwood is responsible for the vegetable garden at the New Light Missionary Baptist Church, which was created May 2013 to provide physical activity and fresh produce for seniors. This area of north Baton Rouge is considered a food desert. The USDA defines food deserts as urban neighborhoods and rural towns without ready access to fresh, healthy, and affordable food. The lack of access contributes to a poor diet and can lead to higher levels of obesity and other diet-related diseases, such as diabetes and heart disease. Gardens help bring relief to food deserts. The SU Ag Center, by creating gardens in the community. is contributing to the improvement of the quality of life of local residents. Elwood worked with the seniors to establish the garden on church grounds in the Scotlandville area. The church is located at 650 Blount Road, Baton Rouge; Rev. Gil H. Wright, Pastor.



### Congo medical doctors tour SU Ag Center

On June 13, 2013, the Southern University Ag Center welcomed visitors from the Democratic Republic of Congo who were on tour of the United States. The two medical doctors came to learn about the best ways to involve agriculture in a holistic medical practice. They are missionaries in search of innovative ways to address health issues in their country. One of their challenges is providing medical treatment without adequate nutrition to sustain good health. Their goal is to offer medical care along with nutritional education and sustainable small garden production. The duo came under the auspices of the United Methodist Church, Dr. Adell Brown Jr., Executive Vice Chancellor and Vice Chancellor for Research, took an interest in their discussion at the 100 Hundred Black Men forum and invited them to learn what the SU Ag Center has to offer in terms of possible medicinal crop production.

Dr. Kit Chin, professor of plant science and Dr. Yadong Qi, professor of Urban Forestry, currently conducting research on the health benefits of hibiscus offered relevant suggestions about a partnership to introduce the tropical plant to the Congo on a trial basis. The visiting medical doctors embraced the idea and left with high hopes for collaboration, sample of hibiscus seeds; and promised to report the result of the hibiscus trial progress to the SU Ag Center.



**SUSLA Partners Biz Camp** 

Young people from area high schools and the Shreveport Job Corps opened the James K. Elrod BizCamp marketplace at the Louisiana Boardwalk in Bossier City, where they were offered limited-time deals on wholesale items such as branded merchandise, jerseys and various other household items.

The one-day sales event was held as a culmination of the 13th annual JKE BizCamp, an endeavor created in 2001 by James Elrod, President and CEO of Willis-Knighton Health System through the Inner City Entrepreneur Institute.

The two-week program is designed to familiarize inner-city youth with developing and executing a viable small business plan to give them the tools to revitalize the community. "I found out about it at Byrd," said Kenton Jackson, a 15-year-old sophomore at the school. "I love every second of it. I've learned that being

an entrepreneur is not an easy thing. It's going to take some perseverance, hard work and dedication. Not just anyone can be an entrepreneur."

Over the course of the two-week camp, participants learned about formulating a business model, using PowerPoint to illustrate the revenue-generating idea, and the budget-

ing and finances required to make it work.

"It's a program that teaches entrepreneurship to kids anywhere from the ages of 14 all the way up to 21," said Darrin Dixon, Director of the Small Business Development Center at Southern University-Shreveport.

Dixon, who has helped young people learn more about the financial aspect of owning a business, said this year, just more than 30 students attended the two-week camp. "We work from a format that's pretty easy to understand, it's just getting them to understand the terminology and all the nuances that go with the financial statements to get them to see the big picture," Dixon said.

BizCamp is the educational arm of the nonprofit organization, and state Representative Roy Burrell, ICE co-founder and manager director, said it is an essential part of an ongoing endeavor to rebuild Shreveport's inner city.

"The mission of ICE overall is to create wealth back into an area that has been pretty much devastated in terms of its tax base, schools and that type of thing," Burrell said. "In order to recreate an economy for this inner-city area, you need to have strong businesses that can create the revenue necessary to create jobs."

BizCamp is a program that ICE undertook to focus on young people. "We felt if we could grow our own entrepreneurs, they would be more responsive to the needs of the area where they actually live," Burrell said.

On July 24, members of ICE plan to host a recognition banquet, where members will honor the best of area law enforcement.

## **SUSLA Receives EPA Job Training Grant**

The U.S. Environmental Protection Agency (EPA) announced that Southern University at Shreveport is one of the recipients of the Environmental Workforce Development and Job Training grant. With the award amount of \$200,000.00 SUSLA will use the funds to recruit, train, and find employment for individuals who fall into one or more of these categories: unemployed, underemployed, or lack adequate skills to be marketable in the workplace.

Trainees who complete the program will be assisted in acquiring employment in environmental health and safety jobs that will also provide them with sustaining wages to support their families. Graduates of the program will acquire training in a variety of areas such as environmental health and safety, lead and asbestos abatement, wastewater treatment, Brownfields assessment and cleanup, leaking underground storage tank removal, recycling, and emergency response. They will also receive a license from the EPA Department as an Asbestos Contract Supervisor. Graduates will be provided with certifications in OSHA and HAZWOPER certifications from the Shreveport Fire Academy; and CPR and First Aid certifications from the American

Heart Saver Association.


