SOUTHERN UNIVERSITY LAW CENTER WELCOMED NOTABLE FIGURES FOR SECOND ANNUAL HENRIETTA LACKS SYMPOSIUM



The Southern University Law Center, in partnership with the “Increasing Clinicians of Diversity” Initiative through the Louisiana Department of Health, Southern University A&M College and the Southern University Museum of Art Cultural and Heritage Center, hosted the second annual Henrietta Lacks Symposium on March 22-23.

This year’s theme was “Humanizing HER: Elevating the conversation of fertility, health equity, and maternal health”. The symposium aimed to elevate Henrietta Lacks’ family’s 70-year quest for justice and illuminate the crucial intersections of health equity, fertility, medical racism, and Black maternal well-being.

The two-day conference began with an intimate dialogue titled “Cultural Reality: A Conversation with Nikole Hannah-Jones and Ben Crump”. The Pulitzer Prize and Emmy award-winning journalist and nationally recognized civil rights attorney, respectively, conversed about the junction between academia and advocacy. In addition, both authors discussed excerpts from their award-winning and best-selling books that have sparked global conversations regarding the legacy of US enslavement and the discriminatory practices of the US criminal justice system.

Healthcare professionals, legal scholars, and advocates also joined to provide insight on fertility and black maternal health, along with updates on the historical Henrietta Lacks court cases.

The panel conversations included Dr. Neil Chappell, fertility specialist and advocate; Frankie Robertson, president and founder of The Amandla Group, LLC, Dr. Yolunda Taylor, obstetrician gynecologist; and more.

April is Second Chance Month, which brings awareness to formerly incarcerated persons reacclimating themselves to society and reality. To bring awareness to issues surrounding re-entry and clemency, Southern University Law Center (SULC) and the Office of Mayor Sharon Weston Broome hosted two-day fireside chat and movie screening.

On Monday, April 1, Sibil Fox and Rob Richardson sat down with attendees to share their experiences with incarceration and how their marriage and family conquered this momentary separation. Widely known as “Fox and Rob”, they are a New Orleans–based couple who experienced twenty-one years as an incarcerated family and whose story is told in the acclaimed, award-winning documentary, *Time*, which was shown at the event. Following the screening, Fox

and Rob engaged in a conversation where they gave the audience a lens into their lives and fight for justice.

Clemency and re-entry were on the agenda for day two. On Tuesday, April 2, attorney and civil rights advocate, Brittany Barnett, discussed her expertise and experience with achieving executive clemency for her clients and establishing non-profits to assist families with navigating the impact of the criminal justice system. Barnett’s recent memoir, “A Knock At Midnight”, was chosen by the Amazon Editors as the number one Best Book of 2020, an NAACP Image Award nominee, and Los Angeles Times Book Prize Finalist.
